**SHERIFF'S OFFICE, Special Operations Division, Traffic Safety Unit** - Traffic Analysis / Red Light Photo Enforcement

**Present:** Corporal Brian Connelly

Lt. Robert Russell Sgt. Richard Russell Captain Steve Hall

Corporal Connelly provided an overview of the 2014 crash statistics for the county. He noted the highest frequency of crashes occurred between 3 pm and 6 pm, with the highest concentration of these collisions in the area of Rt. 235 between MD Rt. 4 and MD Rt. 246. In addition to several initiatives implemented by the Sheriff's Office to prevent collisions and

change driver behavior, the Sheriff's Office is researching the use of Red Light Cameras. Corporal Connelly presented the process required and the associated cost to implement red light photo enforcement.
