Chairman Theodore Belleavoine called the meeting to order at 1:00 p.m. and introduced the Board to the audience. Member Currie moved to approve the minutes of December 8, 2016 and it was seconded by Member Kohl.

Old Business

Extensions of Conditional Approvals

Last Drop Country Bar – William Dain Johnson- requesting extension of conditional approval.

William Dain Johnson appeared before the Board and was sworn in. Mr. Johnson explained that all the renovation work has not been completed and would like to request an extension. Member Hall made a motion for a 60 day conditional approval and was seconded by Member Currie. Motion carried.

Twist Wine & Spirits- Purnima B. Patel, Licensee

a) Commission of acts on licensed premises contrary to State law in violation of § 5.04(b) \$\frac{4}{6}\$cts Contrary to Law+of the Rules and Regulations of the Alcohol Beverage Board of St. Mary \$\frac{4}{6}\$ County; to wit: Distribution of Tobacco Product or Paraphernalia to Minor in violation of § 10-107 of the Criminal Law Section of the Maryland Annotated Code.

Purnima Patel appeared before the Board and was sworn in. Ms. Patel admitted to the violation. Board attorney, James Tanavage read into testimony the details of the violation. Member Hall made the motion for a fine of \$500.00; \$250.00 held in abeyance, pending no further violations in the next three (3) years; payment to be made within 10 days and attend RAST training. The motion was seconded by Member Currie. Motion carried.

International Beverages, Deli & Cadillac Jacks- Paul Choporis, Licensee

a) Sale of alcoholic beverages to a person under the age of twenty-one (21) in violation of §6-304 of the Alcohol Beverages Article of the Annotated Code of Maryland and §5.04(j) of the Rules and Regulations of the Alcohol Beverage Board of St. Maryos County.

Paul Choporis appeared before the Board and was sworn in. Mr. Choporis admitted to the violation. Board attorney, James Tanavage read into testimony the details of the violation. Member Kohl made the motion for a fine of \$1000.00; \$500.00 held in abeyance, pending no further violations in the next three (3) years; payment to be made within 10 days and attend RAST training. The motion was seconded by Member Currie. During discussion, the motion was amended to a fine of \$500.00; \$250.00 held in abeyance, pending no further violations in the next three (3) years; payment to be made within 10 days and attend RAST training. Motion carried.

Jeffrey Randolph Baumbach, Employee

a) The above individual, was an employee of a license holder and sold or provided alcoholic beverages to an individual under the age of twenty-one years in violation of §28-2802(b) of the Alcohol Beverages Article of the Annotated Code of Maryland

Jeffrey Baumbach appeared before the Board and was sworn in. Mr. Baumbach admitted to the violation. Member Currie made a motion for a \$250.00 fine and RAST training and was seconded by Member Hall. Motion carried.

Hermanville C-Store- Darlene Newman & Mohammad Qureshi, Licensees

a) Sale of alcoholic beverages to a person under the age of twenty-one (21) in violation of §6-304 of the Alcohol Beverages Article of the Annotated Code of Maryland and §5.04(j) of the Rules and Regulations of the Alcohol Beverage Board of St. Marycs County

Attorney Mike Davis was present to represent the licensees. Ms. Newman was absent but Mr. Davis stated he represented her. Mohammad Qureshi appeared before the Board and was sworn in. Mr. Qureshi admitted to the first violation. Board attorney, James Tanavage read into testimony the details of the violation. Member Hall made the motion for a fine of \$1000.00; \$500.00 held in abeyance, pending no further violations in the next three (3) years; payment to be made within 10 days and attend RAST training. Ms. Hildebrand brought to the attention of the Board that this is a second violation and that there is \$500.00 from the previous violation that had been held in abeyance. Member Hall amends his motion to include the \$500.00. The motion was seconded by Member Currie. During discussion, Member Kohl stated that they were assessing the same fine for this second offense as was given for the first offense. The vote was in favor 3:1. Chairman Belleavoine, Member Hall and Member Currie in favor, Member Kohl opposed. Motion carried.

Member Currie made the motion for a fine of \$500.00; \$250.00 held in abeyance, pending no further violations in the next three (3) years; payment to be made within 10 days and attend RAST training. Chairman Belleavoine stated he felt any plans to add or increase fees should be presented to the County Commissioners after budget session as a courtesy and to get public opinion.
