The Commissioners met with the Commanding Officer and representatives of NAS Patuxent River at 9:00 am at the Frank Knox Employment Development Center at NAS/PAX River for the semi-annual encroachment mitigation and prevention meeting. Topics covered at the meeting included recognition of 100 years of Naval Aviation being celebrated this year, updates on the "Navy Shore Vision 2035," the St. Mary's County Lexington Park Master Plan, Lexington Park Development District Master Plan, Lexington Park Revitalization, and the Navy's Joint Land Use Study. It was suggested that future joint meetings be referred to as "St. Mary's County-Patuxent River Naval Air Station Community Partnership Meeting." The joint meeting was followed by a tour of several sites on the base.

Commissioner President Russell called the business meeting to order at 2:00 pm at the Chesapeake Building meeting room, Governmental Center campus.

Commissioner Jarboe moved, seconded by Commissioner Morris, to approve the Southern Maryland Interoperability Executive Committee (SMIEC) governance structure and by-laws and to authorize Commissioner President to execute SMIEC by-

laws on behalf of the Department of Public Safety and to execute the budget amendment closing out the Interoperability Emergency Communication Grant Project US0969 and returning the remaining project funds in the amount of \$94,251 to the supplemental reserve. Motion carried 5-0.

Commissioner Morris moved, seconded by Commissioner Morgan, to approve and authorize Commissioner President Jack Russell to execute a Right-of-Entry Agreement and a Development Review Application to permit the St. Mary's County Board of Education to conduct tests and evaluations of, and to obtain review by Technical Evaluation Committee, of Lot 1, "Elementary School Site," per plat of Minor Subdivision by Loiederman Soltesz Associates, Inc., dated October 13, 2010, being property owned by St. Mary's County and approved as the site of a new elementary school. ### DECISION ON PROPOSED ABANDONMENT OF PAGE ROAD RIGHT-OF-WAY

**Present:** David Weiskopf, Deputy County Attorney

Mr. Weiskopf requested adoption of a Resolution to finalize the abandonment and transfer of Page Road to Robert A. Morehouse and Deborah A. O'Donnell. Page Road, a 40 foot right-of-way, was recorded in 1952 and dedicated to public use on a subdivision plat. The road was never constructed and there are no plans to do so. The abutting property owners, Mr. Morehouse and Ms. O'Donnell, requested that the road be closed and the County execute a deed granting the road back to them. The Board of County Commissioners held a public hearing on this matter on

May 4, 2010. No public comments other than those of the property owner, Mr. Morehouse, and his attorney, Mr. Densford, were received at the hearing or during the open record period.

Commissioner Jarboe moved, seconded by Commissioner Morgan, to approve and adopt a Resolution to abandon and transfer Page Road, containing 0.75 acres of land, located in the First (lst) Election District of St. Mary's County to Robert A. Morehouse and Deborah A. O'Donnell. Motion carried 5-0.

## DECISION ON PROPOSED AMENDMENT TO CHAPTER 267 OF THE ST. MARY'S COUNTY CODE TO EXTEND THE PROPERTY TAX CREDIT FOR CERTAIN FIRE PROTECTION RESIDENTIAL SPRINKLER SYSTEMS

The property tax credit for certain fire protection residential sprinkler systems adopted in 2008 will expire on February 1, 2011. Following a public hearing on January 11, 2011, Mr. Sparling drafted a proposed Ordinance leaving the credit amount and extension timeframe to the discretion of the Board. Mr. Berlage recommended extending the Ordinance for three years to coincide with the next review of the International Building Code. The Commissioners supported the recommendation. Commissioner Morgan suggested increasing the amounts for new construction and retrofit by \$500 each.

Commissioner Morgan moved: In the second part of the motion relative to the credits, I would propose that the amount of the credit remain at \$26,250 on an annually appropriated basis, but on a per house unit, the amount of the new construction credit would be \$2,000, and the amount of the retrofit credit would increase by \$500 to \$2,500. Motion failed for lack of a second.

Commissioner Jarboe moved, seconded by Commissioner Jones, to adopt the proposed Ordinance to amend Section 267-71 of the St. Mary's County Code to extend the property tax credit for certain fire protection residential sprinkler systems with the following additions: period of extension shall be from February 1, 2008, through February 1, 2014, and amount of credit shall be \$1,500 for new residence and \$2,000 to retrofit. Motion carried 5-0.
