The Carter State Office Building, located on the Governmental Campus in Leonardtown, was leased by the state for a period of twenty years, subject to annual appropriation and to acquire the building after 20 years for no additional consideration. Included in the Lease Agreement is a Project Site Description of 6.64 acres, more or less. The County is proposing a reduction in the transfer parcel and a public hearing is required as part of the process of the transfer.
