Of the bills requested by the Commissioners, 12 letters of support have been submitted, one bill has been withdrawn, and two repeals have not moved forward. SB736 regarding the Public Facility Bond request for \$26.3 million refers to the Capital Improvement Budget can be discussed this afternoon after the budget work session along with SB735 and SB737 which also pertains to CIP funding.
