DECISION FROM PUBLIC HEARING ON THE PROPOSED PROPERTY TAX CREDIT FOR CERTAIN HABITAT FOR HUMANITY REAL PROPERTY

On, March 1, 2011, the Board of County Commissioners held a public hearing on the proposed text amendment. No public comments were received during the hearing, nor were any received during the tenday, open record period. Mr. Schaller responded to a suggestion made by Commissioner Jarboe during the Hearing to include a tax exemption for other non-profit organizations. He reiterated that the legislative authority granted at this time was only for Habitat for Humanity and if other entities wanted the same exclusion, new legislative proposals would be required.

Commissioner Morris moved, seconded by Commissioner Morgan, to close the public record and sign the Ordinance as presented granting a property tax credit against the County property tax imposed on real property for real property that is owned by Habitat for Humanity with the intention of relinquishing ownership in the immediate future and used exclusively for the purpose of rehabilitation and transfer to a private owner, pursuant to the Property Tax Article §9-252 of the Annotated Code of Maryland. Motion carried 5-0.
