  - o Why: Citizens, staff and local government leaders can be assured that Accreditation provides assurances that agencies have the capacity to deliver high quality programs, facilities and services to the community it serves.
  - NRPA CAPRA video provides some reasons why CAPRA Accreditation is a great benefit to communities all around the country.
