A. OFFICE OF THE COUNTY ATTORNEY - Legislative Updates

The following bills have passed: Metropolitan Commission bill (HB 275); Public Facility Bonds; the two alcohol beverage bills that related to St. Mary's County; the Burial Sites bill; the Budget Reconciliation and Financing Act of 2018 (SDAT costs were not passed on to the Counties); and the Transportation - Highway User Revenues - Distribution bill.
