A. Informational Briefing on St. Mary's County's Public School's Youth Drug Prevention Summit - "Changing our Culture"

The St. Mary's County Public Schools hosted a student sponsored a Youth Drug Prevention Summit on March 10, 2014. The purpose for the summit was to increase awareness and educate students about the risks and dangers associated with substance misuse and generate discussion about future projects for school age children. Over 150 students, representing middle and high schools both public and private, attended the summit. The sessions were led and facilitated by students with the expectation that students will interact and communicate more effectively with their peers.

## B. COLLEGE OF SOUTHERN MD: College of Southern Maryland: Annual State of the College

Mr. Middleton noted the responsibility of the Board of Trustees for the College is to provide effective oversight of operations and provide strategic direction to their mission. He announced that the college received its Middle States 10-year Re-accreditation in 2014.

Dr. Gotfried provided an overview of the history of the College of Southern Maryland, new programs and courses, four-year college transfer agreements, and plans for the future, including the building of a new Center for Trades and Energy which will be centrally located in Mechanicsville to accommodate all

three counties. He also noted the changing dynamics at the school with part-time students making up 83% of the 2,277 students enrolled at the Leonardtown campus, and only 43% of them being between the ages of 18-21.

# C. DEPT. OF FINANCE AND ST. MARY'S COUNTY METROPOLITAN COMMISSION: Presentation of Debt Capacity Study completed by Davenport Public Finance

The 2015 Debt Policy Study revealed that both the County general government and the St. Mary's County Metropolitan Commission (MetCom) are in strong financial condition as evidenced by comparatives, national medians, and industry best practices. Not only does the County have the capacity to carry out its planned 5-Year CIP debt issuances, but it should be able to do so with minimal, if any, impact on current tax rates. MetCom's current and historical operations are solid; however, there may be organizational, strategic, and policy-related areas in which they might improve: (1) consideration of other financing for vehicles besides CDA for debt issuance; (2) issue longer term debt to sponsor intergenerational equity; (3) adoption of financial/debt policies more in-line with a Utility Enterprise Credit; and, (4) establish a true Revenue Credit.

#### 5. DISCUSSION

Commissioner Guy noted he requested this item be on the agenda but the issue has been resolved with the decision made in Annapolis to move the project forward. Commissioner Hewitt thanked the Delegation and Annapolis for their support.
