Motion carried 5-0.

Commissioner Jarboe moved, amended by Commissioner Jones and seconded by Commissioner Morgan, to approve and authorize Commissioner President Russell to execute:

(1) the FY14 ADAA State General Treatment Grant documents for supplemental funding, Projects MD1489, 1497 and 1498, from the Maryland Department of Health and Mental Hygiene on behalf of the Department of Aging and Human Services to enhance general treatment services at Walden for a revised award amount of \$2,335,866;

(2) the related budget amendment to increase the project budget for MD1497 by **\$14,788** \$14,778; and,

(3) the related sub-recipient agreement between the County and Walden Sierra, Inc. Motion carried 5-0.

5. Department of Public Works and Transportation (George Erichsen, Director; Zane Rettstatt, Project Engineer)

Commissioner Jones moved, seconded by Commissioner Morgan, to approve and authorize Commissioner President Russell to execute the budget amendment in the amount of \$7,199, transferring funds from the FIN14 Reserves to MA-1401 for the emergency maintenance dredge of St. Jerome Creek, Southern Prong as presented by staff. Motion carried 5-0.

6. County Administrator (Dr. Rebecca Bridgett)

Commissioner Morgan moved, seconded by Commissioner Jones, to approve and sign a consent letter to the St. Mary's County Community Development Corporation which will serve as written notice, according to Item #25 in the Agreement, terminating the Cooperation and Operation Agreement with the Board of County Commissioners effective June 30, 2014. Motion carried 5-0.

BOARD OF COUNTY COMMISSIONERS SITTING AS THE ST. MARY'S COUNTY BOARD OF HEALTH

Present: Dr. Meenakshi Brewster, M.D., M.P.H., Health Officer Tracy Kubinec, Deputy Health Officer Libby Blair, Director, Health Promotion & Community Services Daryl Calvano, Director, Environmental Health Melanie Gardiner, Director, Public Health Preparedness & Response

Dr. Brewster highlighted three roles of the Board of Health: (1) to inform, educate, and empower individuals; (2) mobilize community partnerships; and (3) provide care. She discussed two major areas of concern for citizens in St. Mary's County-- asthma and heart attack/strokes and new programs being implemented to address them. The "Asthma Control Program" will target children ages 2-18. St. Mary's County is participating in a nation-wide initiative, "Million Hearts," that brings residents, health systems, non-profit organizations, public agencies, and private sector partners from across the country together with the goal of preventing one million heart attacks and strokes by 2017. The Board of Health is working on a pilot program with two local practices that focus on team-based care for blood pressure control. Another initiative is Healthy St. Mary's Partnership, a coalition of public and private partners working together to address priority health issues such as Behavioral Health, Access to Care, Healthy Eating and Active Living, and Tobacco Free Living in St. Mary's County. Other initiatives include an electronic data management system, changes to the fee for service structure, and, preparation of a formal Strategic Plan to be presented for adoption at the next Board of Health meeting.

Commissioner Morris asked if the Board of Health's electronic data was protected against electronic magnetic pulses.

RECONVENE AS BOARD OF COUNTY COMMISSIONERS

Commissioner Jones moved, seconded by Commissioner Morgan, to adjourn as St. Mary's County Board of Health and reconvene as the Board of County Commissioners. Motion carried 5-0.
