APPROVAL OF MINUTES

Commissioner Morgan moved, seconded by Commissioner Jarboe, to adopt the minutes of the meeting of Tuesday, May 3, 2011, as presented. Motion carried 4-0.

Motion carried 4-0.

3. Sheriff's Office (Brian Eley, Civilian Administrator, Erin Shoemaker, Financial Manager)

Commissioner Jarboe moved, seconded by Commissioner Morgan, to authorize the Sheriff's Office to submit the grant application documents electronically and mail for the School Bus Safety Enforcement, Project MD1223, from the Governor's Office of Crime Control and Prevention in the amount of \$35,000 with the hard copy to be submitted for review at the award stage. Motion carried 4-0.

Commissioner Jarboe moved, seconded by Commissioner Morgan, to authorize the Sheriff's Office to submit the grant application documents electronically and mail the Edward Byrne Memorial Justice Assistant Grant (BJAG) Crime Analyst in the amount of \$59,294 with the hard copy to be submitted for review at award stage. Motion carried 4-0.

Commissioner Jarboe moved, seconded by Commissioner Morris, to authorize the Sheriff's Office to submit the grant application documents electronically and mail the Domestic Violence Unit Program (DVUP) in the amount of \$3,964 with the hard copy to be submitted for review at the award stage. Motion carried 4-0.

Commissioner Jarboe moved, seconded by Commissioner Morgan, to authorize the Sheriff's Office to submit the grant application documents electronically for the Bullet Proof Vest Partnership Grant, Project US1216, from the Bureau of Justice in the amount of \$9,690 with the hard copy to be submitted for review at the award stage. Motion carried 4-0.

4. Department of Public Works and Transportation (George Erichsen, Director)

Commissioner Morris moved, seconded by Commissioner Morgan, to approve and authorize Commissioner President Russell to sign the budget amendment in the amount of \$128,000 to restore the Department of Public Works & Transportation budget accounts to the pre-storm level of funding. Motion carried 4-0.

Commissioner Morgan moved, seconded by Commissioner Jarboe, to approve and authorize Commissioner President Russell to execute the budget amendment to realign revenue sources from Transfer Tax to Roads Mitigation in the Stormwater Management Project (HW0503), returning Transfer Tax to the Capital Reserve (FIN11) in the amount of \$8,130. Motion carried 4-0.

Commissioner Morgan moved, seconded by Commissioner Morris, to approve and authorize Commissioner President Russell to execute the Maryland Emergency Management Agency Hazard Mitigation Grant Program Application Maintenance Agreement, for structural enhancements to the Emergency Communications Center, Project PF1004, on behalf of the Department of Public Works and Transportation, and to approve the local funding commitment in the amount of \$125,000 by executing the attached letter of consent. Motion carried 4-0.

5. Department of Public Safety (Bob Kelly, Interim Director)

Commissioner Morris moved, seconded by Commissioner Morgan, to approve and authorize the Commissioner President to execute the budget amendment transferring funds in the amount of \$167,797 in county funding from the FIN11 Capital Reserve to the NexGen 800MHz/Tower Enhancement Project PF1005 for Phase I, whereas the additional costs include securing radio frequencies, performing the design for the phased installations and microwave, and completing the necessary tower structural improvements at the Leonardtown Tower site. Motion carried 4-0.
