4. MAIN AGENDA ACTION ITEMS

A. DEPT. OF FINANCE - Adoption of the FY2018 Budget

Present: Jeannette Cudmore, Chief Financial Officer Patty Steigman, Deputy Finance Officer

Ms. Cudmore provided budget highlights of the FY2018 Operating Budget. The \$221,324,105 budget is \$842,918 less than the FY17 budget. The budget includes \$102,189,940 for the Board of Education; \$51,162,643 for County Departments and Elected Officials; \$38,575,373 for the Sheriff's Office; \$11,255,230 Debt Service; \$5,953,334 for Retiree Health (County), Reserves & Other Costs; \$5,179,648 for other Boards and State Agencies; #4,207,365 for College of Southern Maryland; and \$2,800,572 for the Board of Library Trustees. The Real Property Tax Rate is reduced to \$.8478 per \$100 assessed value. A 10% senior tax credit for those that are 65 years old and has either lived in their home for at least 40 years or who are retired veterans is also included in the budget.

In the late 1990s, the County signed an agreement with the Maryland Department of Housing and Community Development (DHCD) to use \$555,000, the proceeds from the sale of what was then known as the Skip Jack Property, to establish a small business revolving loan program to be administered by the St. Mary's County Community Development Corporation (CDC). Neither the MD DHCD nor the CDC wish to continue the loan agreement program so the state will allow the County to redirect the funds to a Community Development Block Grant eligible project. The CDC proposes to use the funds to construct a 350-foot road section to County road standards between Rogers Dr. and Willows Road.

Commissioner Guy opened the public hearing for public comments.
