Commissioner President Russell called the business meeting to order at 9:00 am in the Chesapeake Building meeting room, Governmental Center.

Commissioner Morris moved, seconded by Commissioner Morgan, to approve and authorize Commissioner President Russell to execute the CLG Educational Set-Aside Subgrant Program application, Project #US1450, from the Maryland Historic Trust on behalf of the Department of Land Use and Growth Management in the amount of \$1,500 for costs associated with members of the Historic Preservation Commission attending preservation conferences and other various educational workshops. Commissioner Jones moved, seconded by Commissioner Jarboe, Motion: to approve and authorize Commissioner President Russell to execute the Job Access Reverse Commute Memorandums of Agreement I, II, and III, Project #'s US1472, US1473 and MD1476 with the Maryland State Department of Human Resources and Department of Social Services in the amount of \$20,000, \$20,000 and \$40,000, respectively, and the Certification of Lobbying. Motion carried 5-0.

4. Sheriff's Office (Sheriff Tim Cameron; Captain Willenborg)

Commissioner Morgan moved, seconded by Commissioner Morris, to authorize the Sheriff's Office staff to submit the grant application documents electronically for the School Bus Safety Enforcement Grant, Project MD1423, from the Governor's Office of Crime Control and Prevention in the amount of \$35,000, and to approve and authorize Commissioner President Russell to execute the hard copy of said Grant Application subsequent to the electronic filing. Motion carried 5-0.

Commissioner Jones moved, seconded by Commissioner Morris, to authorize the Sheriff's Office staff to submit the grant application documents electronically requesting six sworn deputies (School Resource Officers) under the 2013 COPS Hiring Program, from the Bureau of Justice with the hard copy to be submitted for review at the award stage, in the amount of \$1,709,442. DEPT. OF AGING AND HUMAN SERVICES: PROPOSED RESOLUTION TRANSITIONING THE FUNCTIONS OF THE COMMUNITY HEALTH ADVISORY COMMITTEE AND THE HUMAN SERVICES COUNCIL TO A NON-GOVERNMENTAL ORGANIZATION AS A COMMUNITY-BASED COALITION

Present: Lori Jennings-Harris, Director, Dept. of Aging & Human Services Dr. Meenakshi Brewster, Health Officer for St. Mary's County

Ms. Harris noted the accomplishments of the Human Services Council which was formed to oversee collaborative efforts among the Department of Human Services and other human services agencies to maximize the efficiency of providing services to citizens. After careful consideration, it is anticipated that transferring the functions of the Human Services Council and the Health Advisory Committee into a non-governmental organization will better serve the citizens of the County. The proposed coalition will consist of members from the Human Services Council and the Health Advisory Committee, as well as other organizations, agencies, business groups and individuals in the community. Dr. Brewster explained the Local Health Improvement Process and the results of a Health Assessment Needs Survey. As a result of the survey, the coalition will focus on overweight/obesity issues, tobacco exposure, behavioral health, and access to health care which impacts all facets of life including housing, transportation, employment, education, and health inequities.

The Board of County Commissioners signed Resolution No. 2012-68 in November 2012 approving MetCom to enter into a loan agreement with the Maryland Department of Environment (MDE) for the Enhancement Nutrient Removal Project at Marlay-Taylor Water Reclamation Facility. Solicitation for bids was received and the responsible low bidder for the project is \$3M more than the estimated cost. This Resolution will amend the original Resolution to allow MetCom to borrow an additional \$3M needed for the project.

Commissioner Morgan moved, seconded by Commissioner Jones, to approve the Resolution as presented and authorize Commissioner President Jack Russell to sign the Maryland Department of the Environment loan documents for the Enhanced Nutrient Removal (ENR) Project at Marlay-Taylor for amounts not to exceed the project costs approved in the FY13 Capital Improvement Budget and the FY14 Capital Improvement Budget. Motion carried 5-0.
