Commissioner Morgan moved, seconded by Commissioner Morris, to approve and authorize Commissioner President Russell to execute the Agreement between the County and the Bay District Volunteer Fire Department designating Bay District Volunteer Fire Department as a primary fire department for the 8<sup>th</sup> Election District; and to sign the Resolution authorizing the Bay District Volunteer Fire Department to enter into a loan, refinancing with PNC Equipment Finance, LLC, in the maximum amount of \$480,000, for a term not to exceed 84 months. Motion carried 5-0.

MetCom Commissioner Tom Tudor

Ms. Meiser presented MetCom's Operating Budget FY2012, Capital Improvement Budget FY 2012 through FY2017, and Personnel Requests for FY2012.

The proposed Operating Budget includes funding for the additional requested personnel and a service charge rate increase of 4.12% for sewer (an average of \$1.21 per month) and 3.66% for water (an average of \$0.60 per month).

A detailed listing of Capital Improvement Plans for FY2012 to FY2017 was presented. System Improvement charges cover debt services for upgrades and replacements of existing systems and direct pay of smaller projects. This fee is paid monthly by all customers with an allocation on the system. Capital Contribution Charges are designed to cover debt services for loans to build new water supply and sewer collection systems and to expand capacity to provide service to new customers and are paid when the property owner either makes application or is required to connect to a water main or sewer. This is a one time only fee.

Requests and justifications for the following positions were presented:

- One Full-time Wastewater Collections System Operator \$59,270
- One IT Technician (upgrade existing contractual technician to full time regular employee with benefits) \$15,099

• One Legal Assistant (upgrade existing contractual Legal Assistant to regular part-time employee with benefits) - \$12,000
