3. PRESENTATION

A. DEPT. OF ECONOMIC DEVELOPMENT - NAS Patuxent River Enhanced Use Lease Project

Present: Robin Finnacom, Acting Director

Bob Brennan, Executive Director, Maryland Economic Development Corporation (MEDCO) Matthew Hurson, Managing Director Development, Hines Mike Hayes, Director Military Affairs, Dept. of Business and Economic Development

Mr. Hurson presented the history of Hines Interest, LP (Hines) and their accomplishments world-wide. The Navy selected Hines as the exclusive developer of certain land parcels within the Base under the Enhanced Use Lease (EUL) program. The Navy and Hines will enter into a 50-year ground lease. Hines requested the Maryland Economic Development Corporation (MEDCO) partner with them as a sponsor of the financing for the office complexes to be built. MEDCO will own the buildings and Hines will manage the leasing of the space. The new modern state of the art office spaces will be built to house employees currently being housed in antiquated office buildings and trailers. The first phase of the plan is to construct a 150,000 sq. ft. office building followed by two additional office spaces of approximately 600,000 sq. ft. This initiative can possibly better protect the base from future BRAC activities. The impact to the County in regard to taxes with MEDCO owning the buildings is still undetermined.

Commissioner Hewitt suggested that during the planning for the utilization of land on base he would

like to see a 300-car parking lot at the main gate for access to the Patuxent River Naval Air Museum.

4. MAIN AGENDA ACTION ITEMS

A. ST. MARY'S COUNTY METROPOLITAN COMMISSION: Presentation of FY2016 Operating Budget & approval of FY2016 Capital Improvement Budget & FY2017-2021 Capital Improvement Plan

Present: Daniel Ichniowski, Executive Director Rebecca Shick, CFO David Elberti, Chief Engineer

Mr. Ichniowski presented the FY16 Operating Budget and FY16 –FY17 Capital Improvement Budget to the Commissioners for their approval of the Capital Improvement Budget. Mr. Ichniowski noted a public hearing was held on the proposed FY16 Operating Budget, FY16 Capital Improvement Budget, FY16 Service Charge, FY16 System Improvement and Capital Contribution Charges and FY17-FY21 Capital Improvement Plan. The METCOM Board approved the proposed budget and charges on April 23, 2015. Mr. Ichnowski noted that he had responded to the questions in the Commissioners' letter of April 21, 2015, and summarized his responses.

Commissioner Hewitt noted the \$30,000 to close out failing septic systems and wells along with the hook-up fees restricts many individuals from connecting to MetCom and suggested that they figure out a way to provide funding to property owners to be paid off over a period of years.

Pursuant to Section 113-30 of the St. Mary's Code, I move to approve the Metropolitan Commission FY2016 Capital Improvement Budget and FY2017-2021 Capital Improvement Plan

B. ST. MARY'S COUNTY PUBLIC SCHOOLS - Request for Approval of FY 2016 Board of Education Operating and Capital Budget

Present: Jeannette Cudmore, CFO St. Mary's County Government

The Board of Education approved their budget on May 13, 2015, and submitted it to the County on May 14, 2015. Ms. Cudmore provided the Commissioners with an overview of the Board of Education budget and FTE summary. The County is providing \$92,012,136 in recurring appropriations, \$1,988,060 in nonrecurring appropriations, and \$4,014,805 for teacher pensions for a total of \$98,015,001, which is an increase over Maintenance of Effort by \$6 million plus.

Commissioner Hewitt requested amortization information for the school's Debt Service Fund. Ms. Cudmore will provide.

Budget Motion:

I move to approve the Board of Education's operating, revolving, restricted, and capital budgets for FY2016 at the category and fund level, including the FTE positions; and execute the consent letter signifying approval of same.

Annual MSDE Budget Certification Motion:

I move to approve and authorize Commissioner President Guy to execute the Annual Budget Certification Statement to be submitted to the Maryland State Department of Education.

Excludable Costs Motion:

I move to approve and authorize Commissioner President Guy to execute the Excludable Costs Form noting excludable costs in the Board of Education's FY2016 budget total \$1,988,060, and approve the submitting letter to the Maryland State Department of Education.

Appropriation Distribution Motion:

I move that the appropriation of \$94,000,196 will be distributed in equal installments over the fiscal year; and the appropriation for the State pension shift of \$4,014,805 will be paid upon receipt of documentation showing the BOE's payment(s) of these costs to the State.

5. PRESENTATION

A. OFFICE OF THE COUNTY ATTORNEY - St. Mary's County Open Meetings Act

Present: Mr. George Sparling, County Attorney

The St. Mary's County Open Meetings Act enacted in 1976 preceded and is more stringent than the Maryland Open Meetings Act enacted in 1977. Mr. Sparling explained the provisions of the St. Mary's County Open Meetings Act and pointed out the specific differences between the County and State Acts. All other counties in the State follow the State's Open Meeting Act.

Commissioners Jarboe and O'Connor suggested revising the St. Mary's County Open Meetings Act to bring it into today's electronic era.

6. COMMISSIONER'S TIME

The Commissioners highlighted events attended over the past week.

Commissioner O'Connor noted his reasons for voting no on the MetCom budget: (1) St. Clements project was not in the Capital Improvement Budget and he specifically requested it be included; (2) could not vote yes to the CIB until his ethical questions and concerns about practices being conducted at MetCom are addressed, and a yes vote on the CIB would indicate support of the entire budget.
