The FY2018 Board of Education Budget includes an appropriation from the County of \$102,189,149 which is \$2,472,539 more in recurring funds than FY2017. This budget exceeds the Maintenance of Effort by \$1,339,052. The Capital Improvement Budget includes \$7,296,000, of which \$6,253,000 is county funding. Budget Certifications are due to the State by Friday, June 16, 2017.
