Chairman Moses Saldaña called the meeting to order and introduced the Board to the audience. Member Currie moved to approve the minutes of May 14, 2015 and it was seconded by Member Hall. Motion carried.

Old Business:

Extensions of Conditional Approvals

CoCoacs Caribbean Authentic Jerk- Neville Brown and Cynthia Roberson-Requesting 30 day extension of conditional approval of location transfer.

Neville and Paula Brown were sworn in and appeared before the Board to request a 30 day extension. Ms. Brown presented a letter to the Board to speak on behalf of Cynthia Roberson in her absence. Ms. Brown has requested an extension to finish the renovations to their new location. The Board granted a 90 day approval pending the Fire Marshall and the Use and Occupancy. Member Currie made the motion for approval and Member Hall seconded. Motion carried.

New Business

Applications:

Avenue 54- Application for Claude A. Dukes and Daniel P. Snydeman to purchase a Class B (restaurant) BWL license & t/a Avenue 54 (Avenue 54, LLC), 23154 Wetstone Lane, California, MD 20619. And permission for extension of premise for outside dining.

Claude Dukes and Daniel Snydeman were sworn in and appeared before the Board for the approval to purchase a Class B (restaurant) BWL license. Chairman Saldaña asked questions of the experience of the licensees and what their business direction was going to be. It was stated that it would be an on-site license only. The Board granted a 90 day conditional approval pending Fire Marshall, Health Department, Traders, and Use and Occupancy. Member Hall made the motion for approval and Member Currie seconded. Motion carried.

Premise changes:

Guenthers Fine Wine & Spirits. Dan Guenther- Requesting reduction of premise of 288 sq. ft. for the external storage building, which will no longer be in use as of May 31, 2015.

Dan Guenther was sworn in and appeared before the Board to request the reduction of premise for the external storage building. As of May 31, 2015, the premise will no longer need the use of the 288 sq. ft. building that was used for stage. This building has been removed from the premise. Member Currie made the motion for approval and Member Hall seconded. Motion carried.

Quades . George Quade- Requesting permission temporary extension of premise & extra serving counter for outside music events on Aug. 7, 2015 from 8:00 pm to midnight & Aug 16, 2015 from 3:00 pm to 7:00 pm & establish rain dates. And also requesting rain dates for previously approved events.

George Quade was sworn in and appeared before the Board to request permission to outside music events and establish rain dates. The following date was already established but was rained out so this is the requested rain date:

Other Business:

Proposals Rules & Regulations

Removing need for licensee(s) to attend Board meeting for a *reduction* in premise

Update 2.17 to reflect changes in Health Dept. requirements

Include language on postings prohibiting service/sales due to: failure to renew, expiration of license, suspension & revocation

All proposals for rules and regulations were approved by the Board. Member Currie made the motion for approval and Member Hall seconded. Motion carried.

Legislation

Amend 20-109(c) to clarify intent of law to include all premises under the control of an unlicensed for profit business establishment

Adopt language adding §8-219.2, creating a Special beauty salon beer & wine license for St. Maryos County, similar to Montgomery County §8-216.5

Adopt language under §16-507(t) giving the Board authority to also fine an employee found guilty of sales to an underage person, similar to Charles County §16-507(j)(2)(ii)

During this discussion, Dave Dent from the St. Mary Licensed Beverage Association joined the Board in his views on these legislative proposals and/ or rules and regulations as well as a few more. Mr. Dent is in favor of having RAST as a mandatory training for all St. Mary County licensees applying for a new alcohol license. This subject has been razed several times.

Mr. Dent would also like the fee for Beer and Wine Tasting licenses to be lowered. All the subjects were heavily discussed and the Board decided for them to be brought back up at the July meeting for further discussion.
