3. PUBLIC HEARING

OFFICE OF THE COUNTY ATTORNEY - Public Hearing - Revision of Chapter 152 of the Code of St. Mary's County, Maryland and Repeal and Re-enactment of Provisions Establishing and Governing Advisory Boards, Committees, Councils and Commissions

4. PRESENTATION

State Highway Administration (SHA) - MD 4 / Thomas Johnson Bridge Project Planning Study update

Present: Brandon Scott, Assistant Division Chief, Project Management, SHA

Mr. Scott's update included presentation of SHA's preferred, alternate project design described as:

- Bridge four-lane bridge (height tbd)
- St. Mary's County four-lane typical section with hiker/biker trail
- MD 4/MD 235: Single Point Urban Interchange
- Calvert County median widening with MD 4 ramp modification

Location/design approval is expected late Summer 2015.

Commissioner Hewitt requested that SHA keep the following in mind as they proceed through the planning/design process: (1) safety measures to prevent jumping from the bridge; (2) way to alert emergency vehicles immediately so they can get to the accident before traffic back-ups prevent them from getting to the scene and alert drivers there is an incident on the bridge; and (3) keep Commissioners and public informed of construction schedule.
