B. SHERIFF'S OFFICE - Monitoring Support Program - Sex Offender Grant

A. DEPT. OF FINANCE - Decision on Resolution and County Agreement with BDVFD for loan with Community Bank

A public hearing was held on June 28, 2016 requesting approval for Bay District Fire Department to enter into an agreement with Community Bank of the Chesapeake to refinance outstanding loans with a term not to exceed 25 years, at the fixed interest rate of approximately 2.70%.

# C. DEPT. OF LAND USE & GROWTH MANAGEMENT - Review of and Decision on Annual Growth Policy

Present: Dave Chapman, Capital Facilities Planner II Phil Shire, Director

Since the adoption of the Annual Growth Policy in 2008, the cap has been maintained at a growth rate of 1.9%. Due to continued depressed market conditions, actual growth in the county has never approached this cap. Staff is recommending repeal of the Annual Growth Policy as a tool that is not currently needed.

Commissioner Hewitt indicated he would rather keep the Annual Growth Policy on the books in case the economy and the housing market picks up. After further discussion, it was decided to suspend the policy rather than rescind it.
