OFFICE OF THE COUNTY ATTORNEY - Amendment of Chapter 212 of the Code of St. Mary's County, Maryland (Animal Control Regulations - to abolish County fee for state required dog license)

Commissioner Guy opened the Public hearing at 10:30 am.

Notice of Public Hearing was posted in The Enterprise Newspaper June 19 and 26, 2015, and July 3 and 10, 2015. The proposed amendment will remove a local requirement for a dog license and repeal the local fee for obtaining a dog license. The State still requires dog owners to obtain a dog license and rabies shots. The Treasurer's Office will continue to issue the license. Mr. Sparling noted the County will be doing a global review of the Animal Control Ordinance, and a new draft ordinance should be available for presentation by October 2015.

Commissioner Guy opened the public hearing for Public Comments.

Public Comments. (Comments as noted below are intended as highlights of testimony given and are not verbatim.)

James Raley, Jr., St. Mary's County Farm Bureau, 26737 Radio Station Way, Leonardtown, MD 20650

Mr. Raley stated he had no position on dog license fees, but expressed concern with some definitions in the Animal Control Ordinance and noted the Farm Bureau will collaborate with Mr. Sparling during the review of the entire ordinance.

Commissioner Guy closed the public hearing at 10:40 am. The record closed today as noted in the Notice of Public Hearing.

A. DEPT. OF PUBLIC WORKS & TRANSPORTATION - Introduction to Comprehensive Solid Waste

Management & Recycling Plan and Request to Schedule Public Hearing

Present: George Erichsen, Director

Nicholas Zurkan, Solid Waste Manager Jason Baer, Project Manager, MD Environmental Services Mathew Sheils, Environment Specialist, MD Environmental Services

Maryland Environmental Services handles all solid waste management and recycling plans throughout the state. Every three years counties are required to revise their plans. Six goals are considered critical in developing the Solid Waste Plan: (1) Preservation and protection of the environment; (2) Conserve natural resources; (3) Encourage public involvement; (4) Implement the use of full cost accounting principles; (5) Identify markets and pilot programs; and (6) Facilitate a regional approach. Mr. Erichsen discussed legislation and regulations handed down from the state. He expressed concern about a "Zero Waste" Executive Order from the previous Governor of Maryland that sets aggressive goals for Maryland counties which would cause the counties to modify their current solid waste and recycling infrastructure and operations. Short term (1-2 years), medium term (3-5 years and long term (6-10 years) action plans were presented.

I move to authorize the Department of Public Works & Transportation to schedule a Public Hearing on Resolution adopting the 2016-2025 Comprehensive Solid Waste Management & Recycling Plan.

B. ST. MARY'S COUNTY METROPOLITAN COMMISSION - Resolution authorizing refinancing of bonds

Present: Rebecca Shick, Chief Financial Officer, MetCom

Sam Ketterman, Davenport & Company Mason McLean, Davenport & Company

Davenport & Company, financial advisors to St. Mary's County and the Metropolitan Commission, solicited competitive proposals from banks to refinance certain Metropolitan Commission obligations for debt service savings. Eight proposals were received and TD Bank provided the lowest rates. The Metropolitan Commission Board approved a resolution on July 13, 2015, to authorize and provide for the issuance and sale of an aggregate principal amount not to exceed Nine Million Seven Hundred and Eighteen Thousand Dollars (\$9,718,000) of bonds. A resolution from the Commissioners of St. Mary's County that pledges "full faith and credit" of the County as security for the loan, as required by Section 113-6 of the County Code, is requested.

I move the Commissioners approve and adopt the Resolution authorizing the Metropolitan Commission Refinancing Bonds in the principal amount not to exceed \$9,718,000, pledging full faith and credit guarantee of the Loans, and authorize Commissioner President Guy to sign the loan documents for one or two loans.
