CALL TO ORDER

Commissioner President Russell called the meeting to order at 9:00 am.

APPROVAL OF MINUTES

Commissioner Jarboe moved, seconded by Commissioner Jones, to adopt the minutes of the meeting of Tuesday, July 26, 2011, as presented. Motion carried 5-0.

Commissioner Jarboe moved, seconded by Commissioner Morgan, to approve and authorize Commissioner President Russell to execute the FY2012 ADAA Substance Abuse Treatment Services grant budget award documents for the overall ADAA Substance Abuse Treatment Services grant project #'s MD1215, 1221, 1236, 1237, 1240, 1249, 1252, 1254, 1255, 1293, 1294, 1297, 1298, 1299, OT1253, US1253, 1255, 1257, and the related budget amendment to breakout the State and County Funding for Marcey House Standard Grant, project #MD1236. Motion carried 5-0.

3. Office of County Attorney (George Sparling, County Attorney; Brandy Morris, Paralegal)

Commissioner Morgan moved, seconded by Commissioner Jones, to approve and authorize Commissioner President Russell to execute an Easement Agreement between the Board of County Commissioners for St. Mary's County and SMECO for the purpose of running a new underground/overhead distribution line to the Home Grown Farmer's Market to accommodate the new business. Motion carried 5-0.

4. Department of Aging (Lori-Jennings-Harris, Director; Peggy Maio, Fiscal Supervisor)

Commissioner Jarboe moved, seconded by Commissioner Morris, to approve and authorize Commissioner President Russell to execute the Maryland Senior Rides Program Grant Agreement, project #MD1205, from the State of Maryland Department of Transportation on behalf of the St. Mary's County Department of Aging in the amount of \$36,250 for transportation services for low-income to moderate-income seniors. Motion carried 5-0.

5. Department of Public Works and Transportation (George Erichsen, Director)

Commissioner Jones moved, seconded by Commissioner Morris, to approve and authorize Commissioner President Russell to sign Public Works Agreement Addendum guaranteeing construction of the roads in the Grandview Haven Subdivision, located in the 4TH Election District with an Expiration Date of August 1, 2013. Motion carried 5-0.

(MaryAnn Coontz, STS Transportation Manager)

Commissioner Morris moved, seconded by Commissioner Jarboe, to approve and authorize Commissioner President Russell to execute the State of Maryland Department of Transportation FY2012 Operating Grant agreements from the Maryland Transit Administration on behalf of the Department of Public Works & Transportation, St. Mary's Transit System; and execute the budget amendment in the amount of \$18,730 increasing the budget for the Public-5311 grant in accordance with the award. Motion carried 5-0.

(James Miller, Engineer, Facilities Engineering & ADA Division; George Fabula; Glenn Saffran; and Patrick Fleming; Maryland Transit Administration)
Mr. Miller displayed a design plan for the Charlotte Hall Park and Ride explaining the

location, the amenities that will available at the site (bus shelters, bike lockers, lighting) and measures being taken to alleviate traffic flow coming south on Rt. 5 turning onto Golden Beach Rd, the expansion of Golden Beach Road to the entrance of the park and ride and the extension of Market Drive. This is the first of two 500 vehicle capacity Park and Rides planned for the northern County. The criteria used when monitoring traffic flow to determine the required vehicle capacity was explained. Until the two new park

and rides are constructed, the current rented space in Charlotte Hall will be utilized. Once constructed, the County will be responsible for snow removal, lighting and any other maintenance costs.

Commissioners Jarboe and Morris expressed concern with the traffic impact on Golden Beach Road. Commissioner Jarboe suggested a more regional site that was not only accessible to a highway but to the old railroad track might be feasible to meet future needs. Commissioners Jarboe asked what the anticipated maintenance fee for the County will be and was told \$25,000.

Commissioner Morgan moved, seconded by Commissioner Jones, to approve and authorize Commissioner President Russell to sign the Intergovernmental Agreement between the Board of County Commissioners for St. Mary's County, Maryland and Maryland Transit Administration for the purpose of constructing a Park & Ride Lot in the 5th Election District, Charlotte Hall, Maryland. Motion carried 3-2. Commissioners Jarboe and Morris voted nay.

6. Department of Human Resources (Sue Sabo, Director)

(Lori Jennings-Harris, Director, Dept. of Aging; Cynthia Brown, Interim Director, Dept. of Human Services)

Ms. Sabo provided the history of the Department of Human Services. Substantial grant cuts and a loss of a number of personnel in the Human Services Department presents the County the opportunity to combine two department's resources, thus saving the cost of another contracted department head and allowing more grant funding to be directed to services.

Commissioner Jarboe moved, seconded by Commissioner Morgan, to approve and authorize staff to implement the proposal to merge the Department of Human Services with the Department of Aging into the Department of Aging and Human Services as presented today by staff. Motion carried 5-0.

DEPT. OF LAND USE AND GROWTH MANAGEMENT: DECISION ON HAYDEN PROPERTY WATER SERVICE CHANGE

Present: Jeffrey Jackman, Senior Planner, Dept. Land Use and Growth Management Dave Chapman, Capital Facilities Planner, Dept. Land Use and Growth Management

A public hearing was held on June 28, 2011, with testimony provided by several individuals. No additional response was received during the 10-day open record period. Approval of the category change is consistent with the Comprehensive Land Use and Growth Plan and is needed for the Board of Education to proceed with plans to construct an elementary school on the property.

Commissioner Morgan expressed concern that Commissioners are voting to put water on the property, but it is still undecided exactly how waste water will be removed. Mr. Savich noted the town of Leonardtown is completing a study to expand their treatment facility in the future.

Commissioner Jarboe read a letter from a citizen questioning Section 21.3.2a. of the Comprehensive Zoning Ordinance concerning public hearing notice requirements and asked if all owners of adjacent property had been properly notified. Mr. Chapman reassured Commissioner Jarboe that notifications were mailed in accordance with current guidelines. Commissioner Russell said now might be the time to look at the way we notify citizen on these issues. Commissioner Jones stated she had conferred with two of her colleagues and was hoping to speak to the other two today to look at the possibly of writing a text amendment to allow us to be more comprehensive in how we do this notification process and have staff review the recommendations.

Commissioner Morgan moved, seconded by Commissioner Jones, in the matter of case CWSP 10-200-004, Water Service Category Change for "the Hayden property", I move to approve and sign a resolution to amend Service Area Map III-32 of the St. Mary's County Comprehensive Water and Sewerage Plan to change the water service category from W-6D to W-3D (service in 3-5 years, developer financed) for 92.3 acres described as Tax Map 32, Parcels 225 and 339 (Lot 1 and Outparcel A) in the 3rd Election District. Motion carried 5-0.

DEPT. OF LAND USE AND GROWTH MANAGEMENT: PROPOSED ZONING MAP AMENDMENT RE WEBSTER FIELD AICUZ OVERLAY (AIR INSTALLATION COMPATIBILITY USE ZONE)

Present: Phil Shire, Acting Director, DLUGM Jeff Jackman, Senior Planner, DLUGM

The Land Use and Growth Department is in the preliminary planning stages of preparing an Air Installation Compatibility Use Zone AICUZ overlay at Webster Field in St. Inigoes. The County's 2010 Comprehensive Plan recommended that the County study alternatives and, as appropriate, initiate the creation of a zoning overlay. This would be similar to the Patuxent River overlay. One issue at Webster Field that was not encountered at Patuxent River is the zoning impact that could potentially affect approximately 43 property owners.

Commissioner Morgan moved to proceed with considering an amendment to the official zoning maps to create an Air Installation Capability Use Zone (AICUZ) overlay in the vicinity of "Outlying Landing Field" (OLF) Webster Field in the St. Inigoes area of the First Election District, and direct the Planning Commission to conduct a public hearing and prepare a recommendation on such proposed overlay zone. Commissioner Jones amended the motion (with concurrence from Commissioner Morgan), seconded by Commissioner Morris, to proceed with considering an amendment to the official zoning maps to create an Air Installation Capability Use Zone (AICUZ) overlay in the vicinity of "Outlying Landing Field" (OLF) Webster Field in the St. Inigoes area of the First Election District, and direct staff to create the overlay map as well as any text amendments necessary and return to this board with a presentation of such. Motion carried 5-0.

OFFICE OF THE COUNTY ATTORNEY: DESIGNATION OF A LOCAL FINANCIAL AUTHORITY AND A FORFEITING AUTHORITY RE ASSET FORFEITURES

Present: George Sparling, County Attorney

The States Attorney, who previously acted as the Forfeiting Authority for the County, has declined to sign an agreement to act as such this year. Negotiations are still underway with the Sheriff's Office. In the interim, the law provides that the County Attorney may act as Forfeitures Authority with the concurrence of the States Attorney. A letter from States Attorney Fritz dated June 28, 2011, provides that concurrence as read by statute. The proposed Resolution will designate the County Attorney as the Forfeiting Authority and the Chief Financial Officer as the local Financial Authority for the County. The reason for some urgency is the number of pending cases, one of which is next week.

Commissioner Jarboe moved, seconded by Commissioner Jones, to approve and adopt the proposed Resolution designating the Chief Financial Officer as the Local Financial Authority and the County Attorney as the Forfeiting Authority to effect the forfeiture of money, vehicles, real property and other tangible and intangible personal property seized by the St. Mary's County Sheriff's Department in connection with violations of the Controlled Dangerous Substance laws pursuant to Title 12 Of The Criminal Procedure Article Of The Annotated Code Of Maryland. Motion carried 4-1. Commissioner Morris voted nay.

PUBLIC HEARING: PROPOSED AMENDMENT OF RESOLUTIONS NO. W/S 92-01 AND W/S 93-02 RE ALLOCATION OF EDUs (EQUIVALENT DWELLING UNITS) (TALL TIMBERS)

Commissioner Russell opened the Public Hearing at 11:33 am.

Phil Shire, Interim Director, Dept. of Land Use and Growth Management

Several old county stores existed in the county prior to zoning regulations. In 1990 a new Rural Commercial Limited (RCL) zoning regulation was adopted to allow these businesses to continue to operate with reasonable expansion rather than to render them non-conforming. The Chief's Store, formerly Schaefer's Store, falls within this zoning. The property then and now contains a post office and a store/bar which has expanded over the years. A discrepancy in the number of EDUs allocated some years ago to Schafer's Store was discovered when WJ Dents & Sons, LLC applied for a transfer of a liquor license from the estate of their father to their LLC. Currently the post office has one (1) EDU and the Store/Bar has one (1) EDU. In accordance with MetCom's "Table of Equivalent Dwelling Units," the property is now entitled to one EDU for the Post Office and four EDUs for the Store/Bar. The proposed amendment is required to restate the allocations.

Commissioner Russell opened the Public Hearing for public comment.

Public Comments. (Comments as noted below are intended as highlights of testimony given and are not verbatim.)

David Dent, 45939 Rolling Rd., Lexington Park, MD 20653

- Father owned old Shafer's Store
- When father passed, family worked hard to develop the store
- It's a community gathering place
- More EDUs needed
- Employs 20 people in Store/Bar/Post Office
- Wants to transfer liquor license from Father's estate to WJ Dents & Sons, LLC

Jackie Meiser, MetCom

- Metcom not objecting to additional EDUs
- Explained Federal grants obtained to build sewerage treatment plant to serve the areas of Tall Timbers, St. George's Island, and Airedele Road that had septic systems that were failing. EPA through MDE required a resolution to document the number of EDUs each area was going to use could not be used for new development
- MetCom surveyed area looking at number of houses and commercial areas
- EDUs granted at that time was one (1) to Post Office and one (1) for the under developed country store. It wasn't a restaurant, wasn't a bar, didn't have 20 seats, it was a little county store where people met, maybe had a drink that is why at that time only 1 EDU was afforded
- MetCom has capacity in system
- Should consider if 5 EDUs, are granted to this property the grinder pump in place was intended for 2 EDUs
- Once amendment is created others in area may want additional EDUs
- In the future, if additional EDUs are granted grinder pumps will need upgraded
- If you are going to put this into place, you want to assure upgrading grinders is required; want to make sure that it is monitored

Joe Stone, Kingston Court

- Grew up in Tall Timbers and is familiar with the store
- In 1990's store had Pool Tables and pool leagues; booths and seats around the bar
- Sons have brought the bar back great meeting place for folks
- Support and ask that you grant request for EDU
