On July 25, 2017 the CSMC approved the Public Hearing for the Comprehensive Water and Sewerage Plan (CWSP). Chapter 113 of the St. Mary's County code was amended in 2011 to require the St. Mary's CWSP to be amended annually to incorporate the approved Capital Improvement Budget (CIB) of the St. Mary's County Metropolitan Commission (MetCom). The FY 2017-2022 CIB, as amended, is proposed to be incorporated into Tables 3-4 and 4-5 of the CWSP. In addition, Table 3-2 is proposed to be updated to address comments from the Maryland Department of Environment regarding water appropriation permits.
