A. DEPT. OF FINANCE - Briefing from Second District Volunteer Fire Department & Rescue Squad for Proposed Tax Increase in FY2019

The Second District Volunteer Fire Department and Rescue Squad leadership are proposing a tax rate increase in FY 2019 to cover increasing operational expenses, equipment costs, and the construction of a new building.

Three recommendations were provided: (1) The renovating and/or adding to the existing Tri-County Animal Shelter (TCAS); (2) The building of a new Bi-Counties Shelter in partnership with Charles County; and (3) The building of a new shelter dedicated to St. Mary's County.

A Hazard Mitigation Committee was formed by the county which included Land Use and Growth Management, Emergency Management & Technology, Public Works and Transportation, Health, Emergency Medical Services, Utilities, Roads, Fire and Police, Education, Town of Leonardtown and local business to update the County's Hazard Mitigation Plan. The Hazard Mitigation Committee has completed the updates and requests a public hearing be held to solicit community input into the plan.

F. DEPT. OF LAND USE & GROWTH MANAGEMENT - Proposed Amendment to the Building Code to Exempt Sheds Up to 600 Square Feet Introduction

A Shed Focus Group was established to consider a building code exemption for sheds between 300 and 600 square feet in area. The focus group consisted of Staff from Land Use and Growth Management, Department of Economic Development, the Health Department and ten residents in or associated with the shed business. The participants recommended that sheds up to 600 square feet be exempt from building inspections. A zoning permit would still be required and the proposed location would be reviewed for floodplain and critical area. Electricity and plumbing would have to be inspected if applicable. A public hearing is requested to get citizen input before a final decision is made.

The IECB requires that additions to one or two family dwellings be energy efficient which includes testing the addition to verify the amount of air leakage is within acceptable limits.
