Chairman Theodore Belleavoine called the meeting to order at 1:00 p.m. and introduced the Board to the audience. Member Hall moved to approve the August 10, 2017 minutes. Motion was seconded by Member Kohl. Motion carried.

New Business

• Applications

Club House Restaurant- Application of John X. Miles to purchase a Class B (restaurant) BWL license & t/a Club House Restaurant (Club House Restaurant, LLC), 23154 Wetstone Lane, California, MD 20619. And permission for extension of premise for outdoor seating.

John Miles appeared before the Board and was sworn in. Mr. Miles stated that the restaurant is currently open and he would like to be able to serve alcohol to the patrons. Member Kohl makes a motion to approve the 60 day conditional approval pending the Traders license. Motion was seconded by Member Hall. Motion carried.

Member Hall made a motion for an approval. Motion was seconded by Vice-Chair Palchinsky. Motion carried.

• Premise changes

 Patuxent Moose Lodge #2393 – Russell Bennet, Melvin Swartz & Kenneth Bean - Requesting permanent extension of premise to include the grass area behind the Lodge.

Russell Bennet, Melvin Swartz and Kenneth Bean appeared before the Board and were sworn in. Mr. Bean spoke for the group by explaining that the Moose was requesting a permanent extension of premise to include the grass area behind the Lodge. The Board expressed their concerns about the area that will be extended, and how it will be manned during events and whether extra members be at all special events for alcohol control of these extended areas. The Board also requested that the same alcohol control policies for inside the building, be used for outdoor events as well. Chairman Belleavoine made a motion for an approval. Motion was seconded by Vice-Chair Palchinsky. Motion carried.

2) **5 South Event Center – John Winters** - Requesting temporary extension of premise for outdoor festival with live music on October 8, 2017, 9:00 AM to 11:00 PM.

John Winters appeared before the Board and was sworn in. Mr. Winters gave an indepth explanation of the event he is requesting for the extension of premise Mr. Winters explained he will have 100% ID check and security for the entire festival area. There will only be 2 entrance points with fencing throughout the rest of the festival area and LUGM had addressed the parking issues in their approval. Vice-Chair Palchinsky made a motion for a 30 day conditional approval pending the Fire Marshall approval. Motion was seconded by Member Kohl. Motion carried.
