H. S. Lancaster, Three Oaks Center

Three Oaks is requesting the county support a Community Development Block Grant Application. The grant would enable delivery of 2,160 square feet of additional space at their

Lei Drive facility. The new modular building will provide 6 transient crisis beds to provide respite care beds as homeless leave the hospital; an intake and assessment staging area for the warm program; and a veterans resource center equipped with a computer lab and space to provide classes, training and mentorship opportunities throughout the year. Booze Allen will be supplying the computers for the lab and all the furnishings for the building will be supplied by local contractors.

Corey Gallagher, 22050 Willow Spring Lane, Apt 306, Lexington Park, MD

Representing the local Navy Supply Corps Foundation, part of the National Organization of Retired and Active Duty Supply Corps Officers. He expressed the local chapter's overwhelming support for this initiative.

Parker Dunn, 22659 Athlone Dr., Great Mills, MD 20634

Former Homeless Veteran. Testified to the support rendered to him and his family in 2013 by Three Oaks at a time when he lost his job and was unable to meet his financial obligations. Programs through Three Oaks provided him the opportunity to find a new job. He supports this initiative.

ST. MARY'S COUNTY PUBLIC SCHOOLS - FY2017-FY2022 State Capital Improvements Program

Dr. Walker presented an overview of the St. Mary's County Public Schools State CIP Plan for FY2017 - FY2022 noting state funding changes; historic state and local CIP funding and infrastructure needs. Ms. Howe presented total enrollment projections among elementary, middle and high schools and seat capacity at each school. Projects planned for FY2017 CIP include a new elementary school located in the central part of the county; Fairlead Academy expansion; partial roof replacement for Piney Point Elementary School; Qualified Zone Academy Bond; Aging School Program; Relocatables for various sites; DSS IT Facility and Warehouse; track repair at Great Mills and Chopticon High Schools; auditorium lighting at three high schools and paving of various parking lots and sidewalks.

Commissioner Hewitt noted he needs clarification on how the FY15 to FY25 total enrollment growth projections were determined. Commissioner O'Connor also requested additional clarification.

I move that the Commissioners of St. Mary's County sign the letter of support for the FY2017 - FY2022 State Capital Improvements Program as approved by the Board of Education on August 26, 2015, to be submitted to the Public School Construction Program, in accordance with state procedures.
