3. MAIN AGENDA ACTION ITEMS

A. ST. MARY'S COUNTY HEALTH DEPARTMENT - BOARD OF HEALTH

Present: Dr. Meenakshi Brewster, Health Officer

An overview of the Zika Virus and changes to Influenza Virus vaccinations were presented. An update on infectious disease control challenges; preparation for Behavioral Health transition from the Dept. of Aging and Human Services to the Health Department; Environmental Health data management; and, the latest proposed regulations for Best Available Technology (BAT) for septic systems was provided. Dr. Brewster noted that the State has a program, Area Health Education Center (AHEC), whose mission is to improve the health status of Marylanders through

community educational partnerships that foster a commitment to enhancing healthcare access in the rural and urban underserved areas of the state. She expressed concern that Southern Maryland is the only region of the state that does not have a dedicated AHEC and indicated she plans to pursue establishing one for the region.

B. OFFICE OF THE COUNTY ATTORNEY - Request to Schedule Public Hearing on Ordinance to Close Bay Front Drive (Extended)

Present: George Sparling, County Attorney

In 1988 the State Highway Administration conveyed Bay Front Drive in Scotland Beach Subdivision to the County. The county has maintained the road; however there is a portion that is unimproved and not maintained by the County. Mr. Sparling requested a public hearing to receive public input on the proposed ordinance be held to close the portion of Bay Front Drive that is not maintained by the St. Mary's County Department of Public Works.
