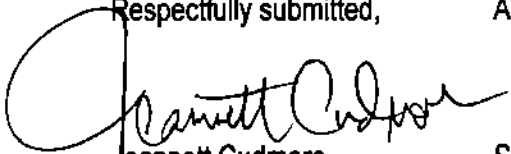

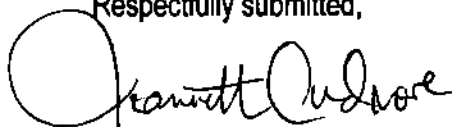

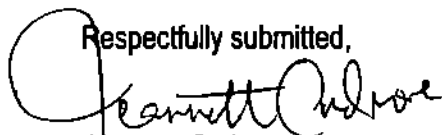

Elaine Kramer made a motion, second by Daniel Raley, to select Charles Schwab & Co., Inc. as Custodian. Motion carried.

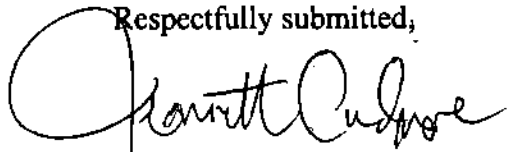
PLAN ADMINISTRATOR UPDATE
