C. DEPT. OF AGING & HUMAN SERVICES - FY2018 Senior Rides Program, Project #MD1805, Notification of Grant Award

I move to approve 1) Senior Rides Program Notification of Grant Award, Project #MD1805, from the Maryland Department of Transportation on behalf of the St. Mary's County Department of Aging & Human Services in the amount of \$36,636 (including other revenue and county funding) to provide door-to-door transportation service for low to moderate income seniors who are unable to utilize other transportation options; and 2) The related budget amendment will increase the grant and other revenue by \$5,008, decrease the local county funds by \$5,008 and restore to the Commissioner's Emergency Reserve, and realign funds to be in accordance with the agreement budget, and authorize the Commissioner President to execute the related documents.

Following additional comments, the Commissioners agreed that the Dept. of Emergency Services and Information Technology have distinct functions and should be two separate entities.

I move to modify Robert Kelly's contract, effectively immediately, to include title change to Chief Information Officer and revised position description amended to lead Information Technology for St. Mary's County Government and have the Commissioner President sign the related documents.
