# 6. PUBLIC HEARING

**A. DEPT. OF LAND USE AND GROWTH MANAGEMENT** - Conduct public hearing for a zoning map amendment for the Hollywood Town Center (Early Properties LLC.)

Commissioner Guy opened the public hearing at 10:00 am.

Present: Phil Shire, Director, Dept. of Land Use and Growth Management Jeff Jackman, Senior Planner, Dept. of Land Use and Growth Management Steve Scott, Attorney representing Earley Properties, LLC Laura Clark, Clarke Consulting LLC

Notice of public hearing was posted in *The Enterprise Newspaper* on November 13 and 20, 2015. Certified letters were mailed to all adjacent property owners and the property was posted. The proposed amendment will amend Map 34, Parcel 327. The 19.81 acre parcel is currently split-zoned Residential Low Density (RL) and Town Center Mixed-Use

(TMX). Earley Properties, LLC requested the entire property be rezoned TMX. The Planning Commission held a public hearing on August 24, 2015, and adopted a resolution recommending approval by the Commissioners of St. Mary's County. Mr. Scott and Ms. Clark presented their analysis of why the entire property should be zoned TMX. They concluded that rezoning the entire property to TMX will allow a cohesive approach to development of the site in a way that is compatible with existing and planned development in the surrounding neighborhoods and will align with the goals and objectives of the St. Mary's County 2010 Comprehensive Plan.

Commissioner O'Connor noted residents in the area had contacted him concerning this property and noted for the record that he would have preferred an evening public hearing to allow citizens who work during the day to attend. Mr. Shire noted the Planning Commission had their public hearing in the evening and there was no public testimony given.

Commissioner Guy opened the hearing for public comment. There were no public comments. Commissioner Guy stated the record would be left open for 10 days to receive public comments on this matter and closed the public hearing at 10:34 am.
