Dr. Rebecca Bridgett, County Administrator opened the public hearing for the FY2020 Recommended Budget at 6:32 pm in the Leonardtown High School Auditorium. Following introductions of honored guests, Dr. Bridgett introduced Commissioner President Guy who introduced the other Commissioners and provided welcoming remarks.

Ms. Cudmore noted there would be six public hearings tonight: Mechanicsville Volunteer Rescue Tax Increase, Constant Yield Tax Rate, Income Tax Rate Increase, Land Use & Growth Management and Public Works & Transportation Fee Rate Changes, Recreation & Parks Activity Fund Fees and the FY2020 Recommended Budget. She presented an overview of the \$ 259.4 million FY2020 Recommended Budget highlighting Revenue Sources and General Fund Expenditures. The budget includes a Constant Yield Rate at \$.08426 per \$100 of assessed value; a property tax increase to 0.9078. Funding for the Board of Education is \$108.3 million and the Sheriff's Office \$44.9million. Funding for County Departments is \$52.4 million. County funding includes 20 planned vehicle replacements, Emergency Services is upgrading its technology and transitioning from its current 9-1-1 service provider, Public Works is expanding bus service, a Merit Increase on the anniversary date for Regular and Regular Part Time employees, and a 1% COLA.
