St. Mary's County Regional Airport Airport Advisory Board Meeting 27 January 2020 Minutes



The Airport Advisory Board (AAB) commenced its 27 January meeting at 6pm at the Airport Terminal.

All members of the Airport Advisory Board were present: Jim Alexander (Chair), Bob Lightstone (Vice Chair), Ted Klapka (Secretary), Albert Babcock, Bryan Barthelme, Carrie Kelly, Bob Zaorski and Alternate Gerald Meyerman. John Deatrick and Allison Swint (Airport Manager) represented Department of Public Works & Transportation (DPWT). Five members of the airport business community and public were present.

Old Business: In culmination of over a year of public input and intensive effort, the Final Drafts of the Airport Rules, the Standard Operating Procedures, and the Minimum Standards for Aeronautical Services were unanimously passed by the AAB to be forwarded to the County with our recommendation that they be adopted by the County.

-The Final Draft of the Annual Report (with minor technical amendments) was unanimously passed by the AAB to be forwarded to the County.

-The 2 December 2019 Meeting Minutes and Action Items were unanimously approved.

Board Reports:

Chairman's Report: The Chairman noted that the Commissioners' Volunteer Reception was 830am 28 January and urged AAB members to attend.

-Both Runways are now open at NAS Pax. Airport traffic should be vigilant to increased military traffic along the Patuxent River.

-FOD remains an issue with the airport construction. The Contractor has switched to using a nylon bristle brush which should improve the situation. Aircraft Owners who believe their aircraft may have suffered FOD damage due to the construction should contact the Airport Manager for the procedures on how to file an insurance claim with the contractor.

-The 50th Anniversary events are now posted on the airport web page. The 21 December Fly-in Farmers Market and fly-in Santa event attracted approximately 500 attendees. Approximately 100 attended the 11 January Model aircraft and Model UAV event at the Terminal building. An AOPA Rusty Pilots seminar and FAA Wings event are scheduled for 8 February. A VMC Club and Wings event to include a visit from the DC FSDO are scheduled for 14 March.

Vice Chairman's Report: Mr. Lightstone noted that the Rules subcommittee had noted several issues that should be flagged for the County's attention and those issues should be passed to the County along with the Final Draft documents.

DPWT Report: Ms. Swint noted that construction is behind schedule and she does not anticipate that Taxiway Alfa will be in full use till July. Mr. Deatrick noted that funding is not yet secured to resurface the existing runway in conjunction with the runway extension efforts. The Board noted that it would be a shame to have new heavy weight extensions but have a runway that was weight limited. It was noted that the Trees along Taxiway Alfa between the T-hangars and new West Ramp block the line of sight of aircraft entering and exiting that taxiway. Mr. Deatrick indicated he would look into that to see if those trees could be removed to mitigate the issue. Ms. Swint indicated the Airport will be served by Food Trucks, initially on Tuesday, Wednesday and Thursdays.

FBO Reports: Utility Services have now been laid to the west end of the airport to facilitate further development. Airport Fuel sales are up since this time last year and do not seem to be impacted by the construction. Fuel Prices remain the lowest in the area.
