Vice Chairman Sacks called the meeting to order at 1: 00 p.m. A motion was made by Member Currie to approve the April minutes as submitted and it was seconded by Member Palchinsky. Motion carried.

Applications:

- Clark's Landing Restaurant
 - Application of Rex A. Shriver, Carol A. Shriver, & Nicolas W. Shriver to transfer Clark's Landing Restaurant's (Jaccar & Sons, Inc.) Class D-BWL license to a Class B (Restaurant) BWL license w/catering privilege, and continue to t/a Clark's Landing Restaurant (Jaccar & Sons, Inc.), 24580 Clarks Landing Lane, Hollywood, MD 20636.

The license holders appeared before the Board requesting to change their license from Class D-BWL to Class B-BWL with catering privileges. Member Currie moved to approve the request and it was seconded by Member Palchinsky. Motion carried.

- Happy Dragon
 - Application of Yuk King Chan Tseng to transfer Happy Dragon Restaurant (Tseng & Chan, Inc.) a Class B (Restaurant) BWL from Tsui Kwok Tseng & Yuk King Chan Tseng & t/a Happy Dragon (Ye's Garden, LLC), 40955 Merchants Lane, Unit 4, Leonardtown, MD 20650.

The current license holder and the Business owners, Xiao Li Ye and Xiong Bin Ye, appeared before the Board for the transfer of the license. Member Palchinsky made the motion to approve the transfer and it was seconded by Member Cullins. Motion carried.

Violations:

- Big T's Crab House & Restaurant – Lois Leicht & Thomas Pilkerton
 - Advertising on internet for distribution of free alcoholic beverages in violation of Section 12-107(b)(2) of Article 2B of the Annotated Code of Maryland

The license holders appeared before the Board reference the violation. Ms. Wood read the charges into the record. They admitted that the violation did in fact occur and that they were unaware of the advertising or the distribution regulations. Member Currie moved to fine the license holders \$250, suspended for six months pending there are no violations in that period. Member Cullins seconded and the

motion carried. There was also a request on the agenda to change the name to Big T's Crab Shack. Member Cullins moved to approve the name change and it was seconded by Member Currie. Motion carried.
