#### **Applications:**

Belden to upgrade their Class A Beer license to a Class A-1 Beer, Wine & Liquor license & t/a Bob's Sunoco (Bob's Sunoco, LLC), 20321 Piney Point Rd., Callaway, MD 20620. Mr. Belden appeared before the Board for the transfer to sell a more upscale wine and liquor selection. Member Currie made the motion and it was seconded by Member Hall. Motion carried

*Riverside Bistro* - Application of Cynthia W. Salvo & Joseph L. Norris, Jr. to purchase a Class B(restaurant) Beer, Wine & Liquor license & t/a Riverside Bistro (Riverside Bistro, LLC) 46555 Dennis Point Way, Drayden, MD 20630. And permission for extension of premise & extra serving counter for outside deck & picnic area. They have a temporary U & O from the Health Department for three months.
