STEPS TO SUBMIT 2024 BINGO REPORTS dated June 1, 2024 through May 31, 2025

1. Prepare the documents to upload for revenues, expenses, and volunteers. It is recommended that you use an excel spreadsheet to maintain your records. If your organization keeps revenues, expenses, and volunteers on one spreadsheet to report 2024 totals, **please upload the same spreadsheet under revenues, expenses, and volunteers, so there is a document in each requested report section.**

• Scanned copies of dated sign in sheets are accepted for the volunteer reporting. Please ensure there is an uploaded sheet for each BINGO date.
