# Commissioner Mattingly

Commissioners attended the Rural Legacy presentation in Annapolis, which was very successful. Hard work by staff as well as those at the State level helped to make 1100 acres along the Patuxent River to be put into the Rural Legacy Program.

Congratulations to the Delegation for the reception in Annapolis – they had a great turnout from Southern Maryland and St. Mary's County was well represented there.

# Commissioner Raley

Reported that there was a recent news release that a special education teacher at Spring Ridge Middle School, Mrs. Anne Smoot, was this year's recipient of *The Washington Post* 2004 Agnes Meyer Outstanding Teacher Award. She and her husband, both teachers at Spring Ridge, are good people, hardworking, and are good examples of people who give something back to the community.

Commissioners received a notice that the Lexington Park Rescue Squad has paid off \$60,000 that was borrowed from the Revolving Fire and Rescue Loan. This is a good example of that loan working. Congratulations were expressed, and the money was used to purchase an ambulance.

Citizens were urged to vote today – there are a lot of good men and women who sacrificed a lot so that we have the right to vote.

# Commissioner President McKay

Attended, along with Commissioner Dement and his wife, the Sheriff, deputies, and members of Calvert and Charles County Sheriff's Department, a raid on four homes in Lexington Park on Friday night.
