# MOTION TO ADD EXECUTIVE SESSION AND BUDGET WORK SESSION TO AGENDA

The BOCC presented a proclamation to Ms. Randall, Ms. Erichsen, and members of the Commission for People with Disabilities recognizing March 2009 as Disabilities Awareness Month.

A presentation was provided focusing on the need for employment opportunities for people with disabilities. Of the approximately 100,000 St. Marys County residents, over 11,000 (5+ years of age) have one or more disabilities.

## NATIONAL WEATHER SERVICE AND DEPT. OF PUBLIC SAFETY: RECOGNITION OF ST. MARYS COUNTY AS A STORM READY COMMUNITY

Present: David Zylak, Director, Department of Public Safety Christopher Strong, Warning Coordination Meteorologist, and Jim Lee, Meteorologist-In-Charge, National Weather Service

The Department of Public Safetys application for St. Marys County to be recognized by the National Weather Service as a StormReady Community was approved by the Maryland StormReady Advisory Board. To be recognized as StormReady requires meeting communications, safety, and preparedness requirements necessary to help citizens receive weather warnings and respond to weather events.

There are 700 counties nationwide recognized as StormReady Communities; with St. Marys being the sixth in the State to achieve this notable accomplishment. The BOCC accepted a certificate from the U.S. Department of Commerce, National Oceanic and Atmospheric Administration (NOAA) acknowledging this accomplishment.

#### SOLID WASTE ADVISORY COMMITTEE ANNUAL REPORT

The report highlighted Solid Waste Advisory Committee (SWAC) 2008 goals, activities, and accomplishments. The SWAC membership requirement was reduced from seven to five by the BOCC in July, 2008. This reduces the number required for a quorum from five to three, alleviating the need to cancel meetings due to not having a quorum.

The report placed emphasis on program expansion, education and the availability of recycling information; e.g., website information, booths at upcoming public events, and information provided on Channel 95 (single stream video).

The committee recommended updating the Countys website to include an explanation of the solid waste fee and a review of the committees purpose to ensure SWACs 2009 goals align with BOCC expectations.

Commissioner President Russell and NAS Patuxent River Commanding Officer Captain Andy Macyko provided opening comments.

## **Encroachment Update**

#### Phil Shire, Acting Director, LU&GM

1. 2009 Update of Comprehensive Land Use Plan

Incorporates the Lexington Park Development District Plan Encroachment issue elements in both plans; AICUZ restrictions and safety goals, Open Space, Flat tops demolition and park plan conversion New restrictions for APZ-2 zone (no new residential development) Storage and warehouse use in APZ-2, OBP zone Interest with Naval Air Museum exhibit dealing with encroachment Mattapany Rural Legacy Area (1300 acres; 169 purchased by the BOCC in 2006, not in development district, cuts down residential density) Comprehensive Plan revision - Last summer, five community meetings held; approximately 25 30 citizens attended/meeting. Refining language and proof-reading. Should be ready to forward to the Planning Commission and the MD Dept. of Planning (60 day period) within six weeks. Planning Commission public hearing in June, followed by BOCC public hearing during the July / August timeframe. October deadline to have plan done. Challenges, not so much Navy base, more with environmental matters.

Zoning Ordinance Text Amendment on Wind Turbines
 Small wind energy system text amendment (TA) adopted December 19, 2008.
 One permit application received yesterday. Previous permit application went through Navy permit review and approval very well.

### LeRoy Mattingly and Fred Pierson, U.S. Navy

3. Pax AICUZ Study Update. It was emphasized that the data and maps provided today are DRAFT and contain preliminary information not yet finalized.

Identifies areas most impacted by noise; comparison of 1979 and 2009 data Identifies changes to 2009 AICUZ Noise Contour Maps (copy handed out to BOCC); data considers aircraft (types/expansion), terrain and surface (land/water), day/night (night heaviest weighed) averages, time (duration), and number of occurrences Map includes clear zones; APZ (accident potential zone) is where an accident is most likely; if one occurs, it would most likely be in the vicinity of a runway. Over flight zones - future

Two APZs dropped; *South Hampton and Glen Forrest areas*. Phil Shire stated that the zoning maps still have the areas designated as APZ. It was clarified that the study is a draft document. John Savich stated that development documents can come and go, but once development occurs, its there.

Timing (approval) go through the chain of command, should be next month Capt. Macyko stressed this is a growing/living document and contains data thats currently available.

No new data for Webster field.

Ready to take place (working for eight years)

Reconstruct 1.4 miles of Great Mills Rd (resurfacing, sidewalks, lighting, storm water mgmt., water and sewer).

Request for bids issued; target awarding contract in May timeframe 18 month project (construction)

Will involve lane closing (to the Navy Base); will ensure direct communications with the Base.

Storm water sewer line work in the Patuxent Park neighborhood should start around April 2<sup>nd</sup>; 10 month duration.
