Ms. Reif presented the Library Board's Annual Report, which included the activities and accomplishments over the past year and plans for the future. Ms. Reif also requested that the Commissioners consider returning at least \$20,000 of the \$35,000 that was cut from the Library's requested budget for FY08 to cover the cost of merit and COLA for library staff.

Commissioner Jarboe commented that Janice Hummel brought an idea to him some time ago about a potential partnership for an internet café. Commissioner Jarboe asked the Board to look at taking the \$20,000 and adding a SmartCo grant on top of that, so that the Library system might end up with full funding and an internet café operating 24/7 in Lexington Park, along with a great example of a public/private partnership with SmartCo.

Announced that the Emergency Services Task Force held its second meeting last week and offered to provide copies of the extensive materials to the Commissioners. Toured the Detention Center and was brought up to speed on current conditions and what is being proposed for the future. Encouraged all Board members to contact Lt. Merican to arrange for the tour. Requested that the press help in getting the word out to the public that there will be two informational meetings to discuss proposed changes to the Transferable Development Rights (TDR) program. The public informational sessions will be: Wednesday, April 25, from 6:30-8:30 pm at Spring Ridge Middle School and on Thursday, April 26, from 6:30-8:30 pm at Chopticon High School. The information meetings are being held prior to the Public Hearing scheduled for May 15 on the proposed text amendments to the zoning ordinance to address specific concerns and answer questions on how the proposal would affect property owners individually. Staff will be in attendance to answer

questions and citizens are encouraged to take the opportunity to attend so that they can have a clear understanding of what is being proposed and can make comments. Public comment on this and other land use issues coming up is strongly encouraged and appreciated.
