Commissioner Raley moved, seconded by Commissioner Dement, to approve and authorize the Commissioner President to execute the MD Dept. of Health and Mental Hygiene Standard Memorandum of Understanding between the Alcohol and Drug Abuse Administration and St. Marys County. Motion carried 5-0.
