## CALL TO ORDER

Commissioner President Russell called the meeting to order at 9:00 am.

## ADDITION TO AGENDA

Commissioner Raley moved, seconded by Commissioner Mattingly, to add an Executive Session today to the agenda for the sole purpose of discussing Personnel, specifically related to boards and committees, as proposed by staff. Motion carried 4-1. (Commissioner Jarboe voted no.)

Ms. Kramer reviewed the Debt Policy (and the resolution that adopts the policy). It was agreed that Ms. Kramer would modify the resolution to reference the Debt Affordability Study, modify the Debt Policy to specify the county's policy to refrain from using derivatives, and return to the BOCC meeting at approximately 1:30 PM with the updated documents for BOCC action.

# ST. MARY'S CO. BOARD OF EDUCATION: DECISION ON STATE CAPITAL IMPROVEMENT SUBMISSION 

Present: Dr. Michael Martirano, Superintendent of Schools Brad Clements, Chief Operating Officer

The FY2011State Capital Improvements Program was presented at the September 22, 2009 Board of County Commissioners meeting.

In conjunction with the Planning Commission's vote (September 21, 2009) on the County's Comprehensive Plan, a number of changes were made relative to land use, residential development, and adequate public facilities. Those changes were summarized by Mr. Derick Berlage, Director, Land Use and Growth Management and were provided to the BOE for inclusion in the revised CIP presented to the BOCC today for approval.

It was clarified by Dr. Martirano that the CIP does not contain an improvement project to upgrade athletic fields to artificial turf. Conducting an athletic field enhancement study will be discussed at this evening's Board of Education meeting. Dr. Martirano said this item is at its infancy phase and therefore, not in the CIP. He said a report will be prepared (in the future) and that funding options will be considered; e.g., fund-raising. The report, specifically relative to any capital budget implications, will be presented to the Board of Education and then to the BOCC.

Commissioner Jarboe moved, seconded by Commissioner Dement, to sign the letter of support for the FY 2011-FY 2016 State Capital Improvements Program presented at our meeting on September 22, 2009, and later revised to incorporate the County's changes to the narrative and as presented today. Motion carried 5-0.

## ST. MARY'S COUNTY HISTORIC PRESERVATION COMMISSION: PRESERVATION PROJECT AWARD TO THE MARYLAND PROVINCE FOR THE SOCIETY OF JESUS

Present: Grace Mary Brady, Historic Preservation Planner
Ms. Brady presented attending member of the St. Mary's County Historic Preservation Commission and award recipients: Father James Casciotti, Chief of Staff for the Maryland Province of Jesuits, Maryland Province of the Society of Jesus; and Father Ryan, Treasurer for the Maryland Province of Jesuits.

Mr. Robert Gibbs, Chair of the St. Mary's County Historic Preservation Commission, nominated the Maryland Province of the Society of Jesus to receive an award for electing to sell all of its holding to the State of Maryland, providing the state with an unprecedented conservation opportunity.

## DEPT. OF HUMAN RESOURCES: UPDATE ON WORKER'S COMPENSATION PROGRAM

Ms. Sabo reviewed program goals, improvements, and costs savings information. On July 1, 2008 (for FY 2009), the county transitioned to a self-insured program with a third-party administrator (SISCO) to assist in administering claims.

The BOCC - SMECO work session commenced at 2:00 PM and was held at SMECO's Regional Office in Leonardtown. The following topics were presented and discussed: Patuxent River Naval Air Station Privatization, Southern Maryland Reliability Project, CoolSentry and EmPower Maryland Program, and Power Pricing and Market Forecast for 2010.

## Patuxent River Naval Air Station Privatization (Ken Capps)

Five year project /\$20million investment; moving operations from the Navy to SMECO (50 year agreement). Navy 'gifted' current utility infrastructure.

Projects: Capital Improvements, Meter Assessment and Installation, Vault Construction, and Laydown Site

- Four sub-stations, includes Webster field and Solomns
- Scope includes implementing many safety improvements and upgrades, (mechanical room vaults upgraded to National Utility Standards), installing 1200 meters (smart meters).
- Finalizing Two-Year Distribution Plan (16 distribution projects, 33 sub-sets)


## Southern Maryland Reliability Project (Tom Dennison)

Project involves assembling and installing two new units (transformers) and transmission line to achieve a 25 percent upgrade in capacity. The new Hewitt Road transformer was installed in April and placed into operation May 1, 2009. The Public Service Commission granted and affirmed SMECO's application for Certificate of Public Convenience and Necessity.

## CoolSentry and EmPower Maryland Program Update (Sonja Cox)

New Load Management Program provides incentives for installing energy efficient programmable thermostats, heat pumps, and water heaters. The program began (installation) November 2008. As of September 28, 2009, 6,600 devices have been installed.

EmPower Maryland Programs offer rebates for purchasing and installing energy efficient HVAC systems and appliances (commercial and residential). Free energy audits (with utility assessment) offered to low/limited income customers.

## Power Pricing and Market Forecast for 2010 (Sonja Cox)

Reviewed graphs depicting energy costs (price per megawatt hour), actual and estimate costs for SMECO purchased power (PJM grid), and the average rate for residential and commercial SMECO customers.

It was noted that SMECO uses SCADA (Supervisory Control and Data Acquisition) to monitor and control systems; however, incompatibilities with MetCom's SCADA system are anticipated. SMECO has considered solar power and methane recovery at land-fills; but projects must be economically feasible to pursue.

Mr. Savich noted the configuration of the Patuxent River Naval Air Base may change (some area may be moved to a less-secure facility area) and encouraged SMECO to review the County's Comprehensive Plan.

## TOUR OF PORT OF LEONARDTOWN WINERY

Laschelle McKay, Town Administrator, members of the Southern Maryland Wine Grower's Cooperative, and Bob Schaller, Director, Dept. of Economic and Community Development, provided a status update and tour of the Port of Leonardtown Winery, located at 23190 Newtowne Neck Road.
