Commissioner Mattingly moved, seconded by Commissioner Dement, to approve the minutes of the Commissioners' meeting of Tuesday, September 28, 2004, as amended. Motion carried.

# 2. State's Attorney's Office, Child Support Division

Prior to the vote to approve the letter of support, Commissioners directed that the draft letter should be revised in order to recognize the need for additional funding for Carver Elementary School.

The Public Works Agreement and Letter of Credit in the amount of \$341,800 were originally issued on December 4, 2002. The road included in this agreement is: McIntosh Court (1,950').
