APPROVAL OF CHECK REGISTER

Commissioner Mattingly moved, seconded by Commissioner Raley, to authorize the Commissioner President to sign the Check Registers as presented. Motion carried 5-0.

APPROVAL OF MINUTES

Commissioner Mattingly moved, seconded by Commissioner Raley, to adopt the minutes of the Commissioners' meeting of December 12, 2006, as presented. Motion carried 5-0.

Motion carried 5-0.

Commissioner Mattingly moved, seconded by Commissioner Dement, to approve and authorize the Commissioner President to sign the Budget Amendment increasing the Tennis Court Replacement Project, #RP0701, by \$5,000, aligning the project with the actual grant. Motion carried 5-0.

Commissioner Dement moved, seconded by Commissioner Jarboe, to approve and authorize the Commissioner President to sign the Budget Amendment decreasing revenues and expenses for the Parks Land Acquisition Project, #RP0604, by \$3,000,000, and increasing the Capital Reserve accounts by that amount. Motion carried 5-0.

Commissioner Dement moved, seconded by Commissioner Mattingly, to approve and authorize the Commissioner President to sign the Budget Amendment decreasing revenues and expenses for the FY05 Fox Harbor Landing Project, #PL0503, by \$68,720, and increasing the Capital Reserve accounts by that amount. Motion carried 5-0.

Commissioner Raley moved, seconded by Commissioner Jarboe, to approve and

authorize the Commissioner President to sign the Budget Amendment closing out revenues and expenses for the Patuxent River Public Landing Project, #PL0601, by \$1,275,000, and increasing the Capital Reserve accounts by that amount. Motion carried 5-0.

Commissioner Jarboe moved, seconded by Commissioner Dement, to approve and authorize the Commissioner President to sign the MOU with the Maryland State Highway Administration for the National Recreation Trails Program, Three Notch Trail, Phase 2, Development Project, #PA0106, and the associated Budget Amendment increasing project revenues and expenses in the amount of \$30,000 in accordance with the grant agreement. Motion carried 5-0.

PATUXENT HABITAT FOR HUMANITY AND THE DEPARTMENT OF ECONOMIC & COMMUNITY DEVELOPMENT: PROPOSED RESOLUTION SUPPORTING USE OF THE COMMUNITY INVESTMENT TAX CREDIT PROGRAM FOR THE "BUILDING AFFORDABLE HOMES IN SOUTHERN MARYLAND" PROJECT

The Patuxent Habitat for Humanity (PHH) applied for and was awarded tax credits under the Community Investment Tax Credit Program, which is administered by the Maryland Department of Housing and Community Development, Division of Neighborhood Revitalization. The name of PHH's project is "Building Affordable Homes in Southern Maryland". The tax credits will enable the PHH to build more affordable homes.

Commissioner Mattingly moved, seconded by Commissioner Jarboe, to approve and sign the Resolution Supporting Use of the Community Investment Tax Credit Program for the Patuxent Habitat for Humanity's Building Affordable Homes in Southern Maryland Project. Motion carried 5-0.

DEPARTMENT OF PUBLIC SAFETY: REQUEST DIRECTION FROM THE BOARD FOR THE ESTABLISHMENT OF AN AM EMERGENCY ALERT RADIO STATION

The presenters briefed the Board on the potential to use a grant from Homeland Security to support the establishment of an AM Emergency Alert Radio Station in St. Mary's County. Phase one, as proposed, includes using Homeland Security grant funding for the installation of the base station, two satellite stations, and four flashing alert signs that are linked to the system. Phase two, which would be budgeted through the St. Mary's County 2008 budget cycle, includes installing two additional satellite locations and four additional flashing alert signs.

Discussion ensued regarding options (existing infrastructure; i.e., St. Mary's College radio station, Patuxent River, and the old WKIK transmitter), the number of transmitters that will be needed (county coverage, watts of power) for the AM Emergency Alert radio station, and bringing in a 'test transmitter' to demonstrate transmitter range. It was clarified by Mr. Kelly that the demo should be conducted on the shoreline.

Commissioner Jarboe suggested that the Board visit the Northern Neck area of Virginia which has experienced success with their emergency alert notification system. A copy of the projected coverage map (computer models) was requested by Commissioner Mattingly. Commissioner Jarboe questioned the cost, in addition to the base coverage transmitter, to install a repeater station for a fire department or rescue squad. Ms. Lilly responded that it's typically about \$30,000 for each transmitter station.

The Board directed staff to meet with the contractor to discuss and address questions and get back to the Board at the first of the year. It was noted that the Homeland Security funds need to be invoiced by March 31, 2007.
