INTRODUCTION

The St. Mary's County Museum Division Board of Trustees (MDT) Board is an eleven (11) member group appointed by the Commissioners of St. Mary's County (CSMC) to "promote through the establishment and maintenance of a Museum and allied projects, programs which will bring about a better understanding and appreciation by the community of history, art, and the sciences indigenous to its area." The Trustees serve in an advisory and not a governing role. We ask questions and provide a sort of public input on Museum Activities. Museum Board of Trustees meetings are normally held on the second Monday of every other month, beginning in January, at8:30 a.m. in Room 14 inside the Potomac Building, 23115 Leonard Hall Drive, Leonardtown, MD. However, given the COVID 19 Pandemic, most meetings were conducted with phone-in option. Normally one meeting a year takes place at the Piney Point Museum and Lighthouse and another at the St. Clements Island Museum. We met at Piney Point but not at St. Clements due to planned renovations there.

In 2021, the Museum Division consisted of four sites: St. Clements Island Museum; Piney Point Lighthouse Museum and Historic Park; the Drayden African AmericanSchoolhouse; the Old Jail Museum in Leonardtown.

Board Membership

2021 saw several changes in membership. Victor Govier resigned from theBoard in July; several members had resigned or rotated off in late 2020. Appointed in December 2020 were Dr. Walter Boswell, Dr. Catherine Bowen, Michael Brown, Robin Finnacom, and Laura Friess for 2021, bringing the Board to full capacity.
