A discussion of minutes followed. Rose Ann Everett, Secretary, has resigned due to health and family reasons. December minutes were accepted. We have no minutes for January 2009. Katie will pull some together from her notes and other members' notes. Cynthia Brown has done minutes for February, which were approved pending appropriate format. March minutes were approved at the April meeting. April minutes were approved pending changes.

Continuing Business:

New Business:

- d) **Scholarship status**: Cynthia reported that in our 2010 budget, \$1500 will be set aside for a scholarship for Returning Women to the College of Southern

- Maryland. This means we can raise up to \$1500 through our banquet for a scholarship; any additional funds raised will revert to the county.
- e) **Membership**: A review of applications to the Commission was conducted, followed by the development of a list in prioritized order which will be forwarded to the Commissioners.
