Notes from the St. Mary's County Commission for Women Meeting March 19, 2018

Minutes and Notes - Mary Ludwig moved and Juanita Nether seconded that the minutes and notes from the February 12, 2018 meeting be accepted as submitted. All voted in favor of the motion.

It is an all-inclusive center for domestic violence victims, with 22 agencies. The spent six years working on the concept.
