BOARD OF COUNTY COMMISSIONERS' MEETING

Tuesday, January 26, 1982

The meeting was called to order at 9:10 a.m.

APPROVAL OF VOUCHERS

Commissioner Aud moved, seconded by Commissioner Arnold, to approve payment of the bills as submitted by the Director of Finance. Motion unanimously carried.

SNOW REMOVAL FUNDS

Present: John D. Raley, Resident Maintenance Engineer, SHA

Mr. Raley appeared before the Commissioners to advise that the \$100,000 that had been allocated for snow removal on County roads has been expended, plus an additional \$26,000. There have been eight different storms in thirteen days. Therefore, Mr. Raley requested an additional amount to be placed in the budget for snow removal for the remainder of the season. The Commissioners advised that they would refer this matter to the Director of Budget and Data Services and return to Mr. Raley with a response as to the amount of the additional allocation.

The County Administrator advised the Commissioners that Governor Hughes met with Maryland Association of County officials regarding a special funding appropriation to Counties that do not have any more funds for snow removal. A final determination has not yet been made.

Later in the meeting after discussion with Joe O'Dell, Director, Budget and Data Services, the Commissioners agreed that if there is an emergency requiring snow removal that Mr. Raley be authorized to proceed. Mr. O'Dell stated that a Budget Change Order will be prepared allocating a certain amount to snow removal.

WORKMEN'S COMPENSATION COVERAGE BRIEFING SEMINAR

The County Administrator presented correspondence from Maryland Association of Counties dated January 15, 1982 regarding a briefing seminar on February 15 on Workmen's Compensation coverage requesting that two officials be appointed from each County to attend. Mr. Cox recommended that the Director of Finance, Harris Sterling, and the Director of Budget and Data Services, Joseph P. O'Dell, attend for St. Mary's County.

The Commissioners gave their concurrence.

SYSTEM REPORT OF COUNTY-OWNED PROPERTY

The County Administrator reviewed with the Commissioners the procedures and related documents for a systematic reporting of County-owned property as developed by the Director of Purchasing and Logistics, Paul Raley, and Planning Technician in the Office of Planning and Zoning, Laura Clarke. The documents have been reviewed and approved by the County Attorney and now require County Commissioner approval.

After review, Commissioner Aud moved, seconded by Commissioner Sayre, to accept the System Report of County-owned Property and procedures set forth therein. Motion unanimously carried.

COMPUTERIZATION EQUIPMENT

The County Administrator presented the following documents pertaining to the acquisition of IBM computer equipment for the Commissioners' review and approval:

- 1. Agreement for Purchase of IBM Machines;
- 2. IBM Maintenance Agreement;
- 3. Agreement for Lease or Rental of IBM Machines;
- 4. Agreement for Purchase of IBM future updates and Model Conversion.

Commissioner Dean moved, seconded by Commissioner Arnold, to authorize Commissioner President Aud to sign the referenced documents as recommended by the Computer Evaluation Committee at last week's meeting. Motion unanimously carried.

PROJECT GATEWAY

The County Administrator advised the Commissioners that in correspondence dated January 13, 1982 from the Governor, it was requested that St. Mary's County designate a contact person for Project Gateway. Mr. Cox recommended that Mrs. Agnes C. (Billye) McGaharn, Senior Services Coordinator, be so designated in that her office will have the primary role in that program.

The Commissioners gave their concurrence.

IN-HOME SERVICES COORDINATOR OFFICE ON AGING

The County Administrator presented a memorandum dated January 25, 1982 from the Personnel Officer recommending the appointment of Virginia Vance to the position of In-Home Services Coordinator, Grade 6, in the Office on Aging, effective February 1, 1982. Funds for this position are to be taken from the Title III-B (Transportation) Program.

TUBMAN-DOUGLAS PROJECT HOME OWNERSHIP PROGRAM

In light of the Commissioners' desire to convert the Tubman-Douglas project, presently under lease to St. Mary's Housing Authority, to private ownership, Mr. Cox presented a request for professional services for a feasibility study to determine the options and alternatives associated with home ownership.

After discussion, the Commissioners gave their concurrence to proceed with the solicitation of proposals for a feasibility study at a cost not to axceed \$5,000, which could be paid back to the County, if and when the project progresses to homeownership.

COMPREHENSIVE RECREATION AND PARKS PLAN

Present: John Baggett, Director, Recreation and Parks

As a follow up to the Commissioners' meeting of December 15, 1982, Mr. Baggett presented the final Five-Year Comprehensive Recreation, Parks, and Open Space Plan for the Commissioners' review and approval. Commissioner Sayre moved, seconded by Commissioner Arnold, to approve the Plan as submitted. Motion unanimously carried.

Further, Mr. Baggett presented the Program Open Space Annual Program for Acquisition for FY 1983 for the Commissioners' approval. Commissioner Sayre moved, seconded by Commissioner Arnold, to approve said Program Acquisition. Motion unanimously carried.

Mr. Baggett advised the Commissioners that both documents will be forwarded to the State Department of Planning and the Department of Natural Resources.

DISTRICT OF COLUMBIA OCEAN DUMPING OF SLUDGE PROPOSAL

The County Administrator brought to the Commissioners' attention correspondence from Tri-County Council dated January 12, 1982 regarding a proposal by the District of Columbia government for the shipping of 700 tons of sludge a day down the Potomac River the Bay to be dumped in the ocean. Mr. Cox recommended that the Commissioners notify the regional EPA office in Philadelphia of the County's concern and call attention to Senate Bill 828, which mandates that hearings be conducted locally. The Commissioners gave their concurrence.

REDISTRICTING PROPOSAL

The County Administrator advised the Commissioners that it was the recommendation of the Democratic Central Committee that St. Mary's County wait until after the 45th day of the current legislative session to conduct a pulic hearing on the Redistricting Plan proposed by the Governor as there will be a specifically adopted plan at that time. March 3, 1982 has been set as the date for the public hearing.

The Commissioners gave their concurrence.
