# REFERENCE TO ARTICLES PUBLISHED IN ENTERPRISE NEWSPAPER DECEMBER 21, 1984

Commissioner Millison asked that these minutes reflect his following comments: Referring to Page A3 of the December 21, 1984 Enterprise article concerning the "Commissioners Write-Off LBW Debt", Commissioner Millison stated that the minutes of December 18, 1984 reflect that he did not vote to write-off that debt. He said he would appreciate very much if Mike Stove would report that accurately in the Enterprise newspaper.

Referring to the December 21, 1984 issue of the Enterprise in the "this and That" column, Commissioner Millison noted that it was mentioned that Commissioners Aud and Millison have been wrapped in a squabble over some financing for a Millison construction project. Mr. Millison stated that he carefully explained his actions to Mr. Stove in the presence of a reporter from WKIK that it would have been illegal, on the advice of his attorney, to have voted for that project. It would have been a conflict of interest and possibly resulted in a big penal fine. Mr. Stove was advised of this. Mr. Stover also reported that Commissioner Millison abstained from voting for the Park Shopping Center. On page 10 of the Commissioners' minutes of December 18, 1984 it was noted that Commissioner Millison returned to the meeting. He explained that "abstain" means to "sit in, but not vote. He added that it would be impossible to abstain from voting and return to the meeting. He was not present at that time. He did not vote. Mr. Millison then asked that Mr. Stover report the facts as they occur.
