STRATEGIC PLANNING

As a follow up to the December 15 Strategic Planning Workshop, Mr. Cox and Ms. Pope appeared before the Commissioners to discuss strategic planning. Ms. Pope reviewed a proposed survey which will be presented to community organizations, church groups, boards and committees for completion and analysis. Included in the handout was a schedule to accomplish the survey process with the goal that by December the Commissioners will have conducted internal and external surveys and the beginning of a strategic plan.

The Commissioners reviewed the proposed survey, made various amendments, and directed staff to revise the survey incorporating the amendments as agreed upon by the Board.

FISCAL YEAR 1996 BUDGET REVIEW

Mr. Wade distributed a handout setting forth certain assumptions, revenue forecast, other sources of revenue, debt service feasibility, capital budget, undesignated fund balance, and recommendations including a budget development schedule. During discussion Mr. Wade requested authorization to proceed with a "Strawman" budget with the assumptions that have been presented.

During the review of the information provided by staff, the Commissioners gave majority consensus to the following:

- Agreed to consider an increase in the tipping fee
- Agreed to consider a fee for transfer station usage
- Agreed to retain tobacco barn credit
- Agreed to retain the property tax rate at \$2,18 per \$100 of assessed valuation.

In conclusion the Commissioners authorized Mr. Wade to proceed with a "Strawman" budget with the referenced assumptions after which the Commissioners will begin the budget work sessions to develop a Recommended Budget by April 1.
