CALL TO ORDER

The meeting was called to order at 9:00 a.m.

APPROVAL OF MINUTES

Commissioner Jarboe moved, seconded by Commissioner Chesser, to approve the minutes of Tuesday, June 20, 1995. Motion carried.

APPROVAL OF BILLS

Commissioner Eagan moved, seconded by Commissioner Chesser, to authorize Commissioner Thompson to sign the Check Register as presented. Motion carried.

COMMENDATION - KATHARINE HURREY

The County Commissioners presented Ms. Hurrey a commendation upon her retirement in recognition of 27 years with the Southern Maryland Library system.

COUNTY ADMINISTRATOR ITEMS

Present:

Charles H. Wade, Acting County Administrator

1) Letter to Board of Education Fiscal Year 1996 Budget

Mr. Wade presented the referenced letter from the Board of Education requesting that the Summary of Revenues and Expenditures by category for the Board of Education FY 1996 Budget be approved.

Commissioner Chesser moved, seconded by Commissioner Eagan to sign the Board of Education budget as presented. Motion carried.

2) Resolution No. 95-31 Transfer of 1995 Bond Funds

Mr. Wade presented Resolution 95-31 which provides for the transfer of \$4,717,000 in 1995 public facilities funds designated for St. Andrews Landfill, to be reduced by like amount, and transferred to Board of Education projects. Mr. Wade continued that approval for this transfer had been given by Piper and Marbury.

Commissioner Jarboe moved, seconded by Commissioner Chesser, to approve Resolution 95-31 as presented. Motion carried.

3) COLA for Non-Public School Bus Drivers

Mr. Wade presented correspondence regarding a 2.5% COLA increase for non-public school bus drivers in that the county has always followed COLA established by the Board of Education for bus drivers. He confirmed that the 2.5% increase was budgeted in the FY 96 budget.

Commissioner Eagan moved, seconded by Commissioner Chesser, that the COLA increase be approved as requested. Motion carried.

4) Management Review and Compensation Study

As a follow up to previous discussions Mr. Wade requested the Commissioners' decision relative to selection of a consultant to conduct a Management Review and Compensation Study for the County.

Commissioner Chesser moved, seconded by Commissioner Thompson, that the contract be approved for the Management Review and Compensation Study with the stipulation that the County Commissioners choose the timeframe and the options. Motion carried 4-1 with Commissioner Brugman voting against.

5) Approval of Bills - Week of July 3

In that the Commissioners will not be meeting the week of July 3 Mr. Wade requested authorization by the Board for Commissioner Thompson to sign the Check Register for the week of July 3.

Commissioner Eagan moved, seconded by Commissioner Jarboe, to give Commissioner Thompson authorization to sign the Check Register for the week of July 3. Motion carried.

6) Clean Water Act Amendments of 1995

As a follow up to last week's discussion Mr. Wade re-presented correspondence prepared by the Commission on the Environment addressed to the Chair of the Committee on Environment and Public Works indicating the Commissioners' concerns that no action be taken on H.R. 961, Clean Water Amendments of 1995 that might degrade the streams, rivers, and buffers that impact the Chesapeake Bay.

Commissioner Jarboe moved, seconded by Commissioner Chesser, to sign and forward the letter to Senator John H. Chaffee regarding the Clean Water Act Amendments of 1995. Motion carried.

7) Response Letters Clark Hilltop Lane

Mr. Wade re-presented correspondence addressed to Minnie C. Russell and Carolyn Fenwick responding to theirs of June 19 regarding the naming of "Clark Hilltop Lane." The return letter explains that a petition was received with five signatures representing three properties requesting "Clark Hilltop Lane" and their petition with two signatures represented one property. Under the adopted petition process, "Clark Hilltop Lane" was approved.

Commissioner Brugman moved, seconded by Commissioner Chesser to sign and forward the letters to Russell and Fenwick as presented. Motion carried.

8) Response Letter Parking at Linda's Cafe

Mr. Wade presented correspondence addressed to Rosemary J. Feruzza in response to her concerns about available parking at Linda's Cafe in the Tulagi Place area, and her not being in favor of a new courthouse.

Commissioner Jarboe moved, seconded by Commissioner Chesser to forward the letter to Ms. Feruzza as presented. Motion carried.

9) Response Letter Cornfield Harbor Drive

Mr. Wade presented correspondence to Mr. Robert Harden regarding flooding conditions in the vicinity of the bridge on Cornfield Harbor Drive.

Commissioner Jarboe moved, seconded by Commissioner Eagan, to forward correspondence to Mr. Harden and stating that the Department of Public Works will be asked to check into the matter. Motion carried.

10) Response Letter Senior Housing

Mr. Wade presented correspondence from Mr. Joseph Dobson concerning the bequest of \$700,000 that was left the County for use for senior housing.

Commissioner Brugman moved, seconded by Commissioner Chesser, to forward a response to Mr. Dobson indicating that only preliminary discussions are taking place at this time. Motion carried.

11) Response Letter Airport Lease Renewal

Mr. Wade presented correspondence to Mr. J. E. Densmore in regard to his concerns about renewal of the Lease and Operating Agreement between the County and the Skydiving Center of Greater Washington, D.C., Inc. in which the Commissioners assured that to date no decision has been made as to whether the County would consent to renew the lease.

Commissioner Jarboe moved, seconded by Commissioner Brugman, to sign and forward the correspondence as presented. Motion carried.

12) Maryland Department of Environment Combs Road/Joe Hazel Road Sewer Project

Mr. Wade presented correspondence addressed to MDE regarding a METCOM grant application for the sewer project on Combs Road/Joe Hazel Road.

Commissioner Eagan moved, seconded by Commissioner Jarboe, to sign and forward the letter to MDE stating the County Commissioners' support for the METCOM grant application. Motion carried.

13) American Healthcare Systems - HealthShare of St. Mary's County

Mr. Wade presented correspondence addressed to Mr. Jack A. Bernard in support of the HealthShare of St. Mary's County for AmHS Cares Award.

Commissioner Thompson commented that this is a very worthwhile program, and hopes it will get the recognition that it deserves.

Commissioner Brugman moved, seconded by Commissioner Jarboe, to sign and forward the HealthShare letter. Motion carried.

14) Department of Public Works Items

Commissioner Jarboe moved, seconded by Commissioner Brugman to approve the Public Works Agreement Addendum as presented. Motion carried.

Queen Arbor Subdivision

Addendum to Public Works Agreement between Harry W. Miller and Sons extending the deadline for completion to October 1, 1995. The Addendum is backed by a Letter of Credit in the amount of \$104,000 with First National Bank of St. Mary's.

Mr. Rollins expressed concern that funds would not continue to be available to continue operating the Teen Center through revenues generated by the Center. In particular, assistance was requested to pay for staff and police.

The Commissioners advised that the Center try to subsidize funds by initiating more fundraising activities to bring in more revenue. Commissioner Eagan emphasized that she is committed to the Teen Center, and is in favor of it never closing. The Commissioners believe that the Center has not been in existence long enough to make a decision for subsidy funds at this time. They will look at the situation again at the end of summer.

Board members requested that a Teen Center Board be established and come under the direction of the County Commissioners. They believed that membership advertised by the Board of County Commissioners would generate more interest.

Commissioner Chesser moved, seconded by Commissioner Eagan, for Mr. Rollins to draft a resolution to establish the Teen Center Board. Motion carried.
