As a follow up to the September 5 Solid Waste issues meeting, Mr. Ichniowski presented an outline of costs and revenues associated with the items that the Commissioners had indicated they would like the County to maintain (rubble cell; convenience centers; recycling at convenience centers; yard waste; tire recycling; self-haul facility; and scale house).

Areas of discussion included costs of continuing the landfill versus privatizing; discontinuing the landfill, but keeping the convenience centers; risk of losing revenues if the County continues landfill; convenience center hours (each opened certain days of the week instead of both being opened six days a week); revenue sources to close current landfill (including general fund or fees such as host fees); whether to use Calvert County's disposal system as an interim measure; and whether to pursue an RFP for privatizing the landfill.

After discussion Commissioner Eagan moved, seconded by Commissioner Jarboe, to instruct staff to proceed with developing a Request for Proposal (RFP) for county-wide solid waste services. Motion carried.

In conclusion the Commissioners agreed that the debt service costs would come from the General Revenue Fund.
