Building Permit Waivers

He suggested that the Commissioners consider during the Zoning Ordinance/Comprehensive Plan update that in cases of fire or natural disasters, the building permit fee be waived to replace the structure even if there is expansion of the original structure. The Commissioners concurred that this be an item of discussion during the update of the Zoning Ordinance/Comprehensive Plan.

FISCAL YEAR 1997 SUPPLEMENTAL BUDGET

The Commissioners conducted a public hearing on the following Fiscal Year 1997 Supplemental Budget requests:

Office of Community Services - HIV Awareness

Supplemental appropriation of \$10,000 in State grant funds to OCS for the purpose of providing an increased awareness of today's profile of HIV and the overlapping problems of substance abuse and HIV infection as they exist in the rural community, and provide a model to increase leadership skills in peer HIV/AIDS education, alcohol, tobacco and other drugs, and households with young children in rural African-American communities headed by women who may be at elevated risk for substance abuse and HIV infection.

Office of Community Services - Alcohol/Drug Impaired Driving Awareness

Supplemental appropriation of \$12,400 in State grant funds to OCS for the purpose of promoting programs in St. Mary's County that increase public awareness and participation in activities that address alcohol/drug impaired driving, incorporating a strategy that will promote healthy life styles with emphasis on delaying onset use of alcohol and other illicit drugs, high risk driving, and provide for teen service, leadership training and safe and sober instructional experience in order to reduce teen driver accidents, and to achieve a level of trained alcohol beverage servers at each licensed beverage vender site that would ensure the presence of a trained certified person on premises at all times.

The hearing was opened for public comment.

The hearing was closed; the record will remain open for ten days for written comments.

The referenced individuals appeared before the Commissioners to present reports, final program requirements, recommendations and request for approval to proceed relative to commuter air services at St. Mary's County Airport.

Mr. Haley explained the formation of a commuter air services committee and the establishment of three subcommittees: operations, facilities, and capital programs.

The presentation included the need for commuter service based on increasing economic growth of the county, a preliminary traffic report, traffic flow forecasts (commuter service between St. Mary's County and principal Washington/Baltimore airports should carry at least 70,000 passengers each year), and that the county could support service with six 19-seat aircraft a day.

Also presented was a Preliminary Design Report which included analysis of four potential sites (Site #2 was the lowest cost and most beneficial site at an estimated cost of \$2,600,000), minimum capital improvement needs (terminal building, aircraft parking ramp, automobile parking lot, obstruction removal), funding requirements and funding sources (including a \$1.437M commitment from the State and the possibility of an additional \$643,000 to complete the project (with a 20% county match).

After discussion Commissioner Chesser moved, seconded by Commissioner Eagan, to authorize proceeding with the project contingent upon receipt of state funding and upon approval of appropriation in the County's Fiscal Year 1998 Budget. Motion carried.

PUBLIC HEARING BIG KINGSTON CREEK

MAINTENANCE DREDGING/TIMBER JETTY REHABILITATION

The Commissioners conducted a public hearing for the discussion of completed plans, specifications and probable construction costs associated with the maintenance dredging and timber jetty rehabilitation at the entrance of Kingston Creek, Eighth Election District.

Mr. Erichsen advised that the taxing district had already been established by Resolution No. 95-37 and the dredging had been done, but because of storm damage from the prior year (Fran and Bertha), there was further damage to the timber jetties. The cost of the taxing district has increased from \$35.44 to \$61.02 per year per owner. Total cost of the jetty project is approximately \$28,000 (50/50 shared by State and County (through taxing district)). Mr. Erichsen pointed out that the original project was based on prior costs, and that he believed it was prudent to inform the property owners of the new costs.

In concluding his presentation Mr. Erichsen referred to the draft Resolution confirming the establishment of the Kingston Creek Waterway Improvement District, which will require the Commissioners' approval after the ten-day open record period.

During discussion Commissioner Thompson questioned the Notice of Public Hearing and the fact that the increased cost to the property owner had not been indicated. Mr. Erichsen explained that a new public informational meeting was held as well as correspondence to each property owner explaining the additional work and costs.

The hearing was opened for comments from the audience.

Judge Clarke Raley indicated that a substantial portion of the work had been accomplished and what remains is the repairs to the eastern jetty.

Mr. Lou Eberle inquired whether the Commissioners had received any negative comments. Commissioner Thompson responded no negative comments had been received.

The public hearing was closed. The record will remain open for ten days after which the Commissioners will take action on the Resolution.

PUBLIC HEARING

WEEKEND INMATE FEE ORDINANCE

The Commissioners conducted a public hearing on a proposed Ordinance for the collection of fees from persons sentenced to weekend jail time for the partial cost of their incarceration. The draft Ordinance includes a waiver provision for these fees if a person sentenced to weekend jail time can prove they are indigent.

Commissioner Chesser questioned the constitutionality of the Ordinance, and Mr. Norman pointed out that the purpose of the Ordinance was for reimbursement not for punishment. Mr. Devenyns indicated that such a fee had been tested at the state level.

The public hearing was closed and the record will remain open for ten days for written comment.

PARCEL OF RECORD LEGISLATION

Mr. Durkin and Mr. Grimm appeared before the Commissioners to discuss possible amendments to House Bill 764 - Validity of Specified Subdivision Lots (Parcel of Record). Mr. Durkin explained that Mr. Grimm had raised some issues regarding some of the amendments crafted by the Commissioners at last week's meeting. He pointed out that the original bill is in Third Reader in the House and that there could be no amendments to that bill in the House. Any amendments offered would have to be done in the Senate and then returned to the House.

Issues included:

- * Proposed language regarding "issuance of a Certificate of Occupancy;" the Building Code had not been adopted until late 1980's and CO's had not been issued until that time.
- * Proposed language "which deed created subdivisions of not more than five lots;" it would be unusual for deeds to create more than one lot and subdivisions were not usually created by Deed.
- * The date for the validity and effectiveness granted to deeds.

After lengthy discussion Commissioner Brugman moved to direct the County Attorney to go forward to send the amended legislation with the March 15, 1978 date for effectiveness and validity of the deeds; with the December 1, 1985 Critical Area and the August 1, 1990 dates remain; and with substitution language for the Certificate of Occupancy and for deeds creating subdivisions. Motion failed for lack of a second.

After further discussion Commissioner Eagan moved, seconded by Commissioner Chesser, to submit proposed legislation that the bill would remain the same with changes as discussed (adding: "provided the parent tract was subdivided into not more than five lots and provide the parent tract existed as one parcel pursuant to deed record on or before March 15, 1978; and "for which lot construction of improvements had been completed before December 1, 1985 in the critical area or before August 1, 1990 in the remainder of the County.") Motion carried.
